# Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Amendment (No 5) Order 2021

under the

Public Health Act 2010

## Explanatory note

The objects of this Order are to—

- (a) exclude the person conducting a service for a funeral or memorial service, or any other person necessary for the conduct or preparation of the service, from the limit on the number of persons allowed to attend a funeral or memorial service, or a gathering following a funeral or memorial service, and
- (b) omit a redundant provision.

This Order is made under section 7 of the *Public Health Act 2010*.

## **Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Amendment (No 5) Order 2021**

### **1 Name of Order**

This Order is the *Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Amendment (No 5) Order 2021*.

### **2 Commencement**

This Order commences on the commencement of Schedule 1[6], [12] and [15] of the *Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Amendment (No 4) Order 2021*.

### **3 Amendment of Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021**

#### **(1) Clause 21 Direction of Minister concerning entering Greater Sydney**

Omit “including the person conducting the service” from clause 21(2)(c).

Insert instead “excluding the person conducting the service and any other person necessary for the conduct and preparation of the service”.

#### **(2) Clause 21(5)**

Omit clause 21(5).

#### **(3) Clause 24 Directions of Minister concerning closure of certain premises**

Omit “including the person conducting the service” from clause 24(1)(a)(iv), (b)(v), (c)(ii), (f)(iii) and (g)(ii).

Insert instead “excluding the person conducting the service and any other person necessary for the conduct and preparation of the service”.

#### **(4) Schedule 1 Reasonable excuses**

Omit “including the person conducting the service” from Schedule 1, item 7(a).

Insert instead “excluding the person conducting the service and any other person necessary for the conduct and preparation of the service”.
