ORDER

Withdrawal of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* an Order has been made on **Mr Ahmed Ibrahim Ali Ouf PHA0001659989**, of Auburn NSW 2144, prohibiting him, until further notice, as a pharmacist, from supplying or having possession of, or manufacturing any preparation, admixture or extract of a drug of addiction as authorised by clauses 101(1) and 102 of the Regulation.

This Order is to take effect on and from 12 July 2021.

**MENTAL HEALTH ACT 2007**  
**Section 109**  
**Declaration of Mental Health Facility**

I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:

(a) DECLARE the following premises to be a declared mental health facility for the purposes of the *Mental Health Act 2007*:

- **The Mental Health Assessment Centre of Cumberland Hospital** located at Building 31, on Paringa Road within the West Campus of Cumberland Hospital, Hainsworth Street, Westmead NSW 2145; and

(b) DECLARE this facility to be designated as a "**mental health emergency assessment class**" facility; and

(c) RESTRICT this facility to the provision of acute assessment functions, where a patient can be held in anticipation of discharge should their clinical condition resolve rapidly, or be transferred to a declared mental health facility of the "mental health assessment and inpatient treatment" class if required, in accordance with all provisions of the *Mental Health Act 2007*, with the exception of:

- i. Chapter 2;
- ii. Division 3 of Part 2 of Chapter 3;
- iii. Division 1 of Part 3 of Chapter 3;
- iv. Sections 57 and 58 of Division 2 of Part 3 of Chapter 3; and

**I, DAVID PEARCE, Executive Director, Mental Health Branch**, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, **DO HEREBY:**

(a) **REVOKE** the Order published in the NSW Government Gazette No. 313 of 13 November 2020, declaring certain premises of Cumberland Hospital, Westmead, to be a declared mental health facility for the purposes of section 109 of the Mental Health Act 2007; and

(b) **DECLARE** the following premises to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:

**Cumberland Hospital West Campus, 1-11 Hainsworth Street, Westmead NSW 2145**, comprising the following units:

- **Acacia Unit**, on Gardens Way
- **Banksia Cottages Complex**, on Hainsworth Street
- **Boronia Unit**, on Gardens Way
- **Hainsworth Unit**, on Paringa Avenue
- **Paringa Unit**, on Paringa Avenue
- **Riverview Unit**, on Paringa Avenue
- **Waratah Cottages Complex**, on Hainsworth Street
- **Willow Cottages Complex**, on Gardens Way
- **Yaralla Unit**, on Paringa Avenue; and

**Approval**  
***Poisons and Therapeutic Goods Regulation 2008 (NSW)***

I, Kerry Chant, Chief Health Officer and delegate of the Secretary NSW Health, under clause 48A(1A)(d) of the *Poisons and Therapeutic Goods Regulation 2008 (NSW)* and s.43 of the *Interpretation Act 1987* do hereby:

1. revoke the approval instrument signed on 26 June 2021 and published in the NSW Government Gazette Number 307 on Friday, 9 July 2021; and
2. approve the SARS-CoV-2 (COVID-19) AstraZeneca (ChAdOx1-S) vaccine (the *approved vaccine*) for the purposes of that clause. Pursuant to clause 48A(1B), this approval is subject to the following conditions:
  - a. The pharmacist must not supply or administer the approved vaccine to a person who is under the age of 40 years.
  - b. The pharmacist must obtain written consent from each patient to whom the approved vaccine is supplied and retain a copy of that consent, using the Australian Government Department of Health *COVID-19 vaccination – Consent form for COVID-19 vaccination*.
  - c. The pharmacist must not supply or administer the approved vaccine to a patient who is not able to consent to the treatment on their own behalf.
  - d. The pharmacist must not supply or administer the approved vaccine to a person who has experienced a serious adverse event after the first administration of the approved vaccine.
  - e. The pharmacist must not supply or administer the approved vaccine to a person with a contra-indication or precaution to vaccination listed in the 'The digital Australian Immunisation Handbook', or in the Australian Technical Advisory Group on Immunisation (ATAGI) advice or guidance, or in the approved product information for the product.
  - f. The pharmacist must provide each patient with the Australian Government advice in relation to what to expect following vaccination with the approved vaccine, and when to seek medical attention following each administration of the vaccine.
  - g. The pharmacist must ensure they remain up to date on any new advice from the Australian Technical Advisory Group on Immunisation (ATAGI) or Therapeutic Goods Administration (TGA) regarding additional precautions or consent requirements for the approved vaccine.
  - h. An intern pharmacist is not authorised to administer or supply the approved vaccine.

In this instrument:

- '*pharmacist*' means a registered pharmacist who administers the approved vaccine in:
  - o a pharmacy business approved under Schedule 5F of the *Health Practitioner Regulation National Law* that has registered to participate in the COVID-19 vaccination program
  - o a residential care facility (as defined under the *Poisons and Therapeutic Goods Regulation 2008*)
  - o a general practice clinic registered to participate in the COVID-19 vaccination program; and
  - o an Aboriginal Medical Service that has registered to participate in the COVID-19 vaccination program.

**This approval can be revoked at any time.**
