Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 21) Order 2021

Explanatory note

The object of this Order is to amend the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) 2021*—

- (a) to include temporarily the local government area of Snowy Monaro Regional in the regional NSW stay at home area, and
- (b) to remove the local government areas of Mid-Western Regional, Central Darling and Walgett from the regional NSW stay at home area on 1 October 2021, but not the suburbs of Menindee, Sunset Strip and Wilcannia, and
- (c) to extend to 11 October 2021 the period for certain other local governments area to be part of the regional NSW stay at home area.

1 Name of Order

This Order is the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) Amendment (No 21) Order 2021*.

2 Commencement

Clause 3(1) and (2) commence at the beginning of 1 October 2021.

3 Amendment of Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order (No 2) 2021

(1) Schedule 1 Categories of area

Insert after clause 3(2)—

(2A) The *regional NSW area* also includes the suburbs of Menindee, Sunset Strip and Wilcannia and the following provisions apply in relation to them—

- (a) the relevant date for the purposes of clause 3.2(5) is 14 August 2021,
- (b) Menindee and Sunset Strip cease to be part of the regional NSW area at the beginning of 8 October 2021,
- (c) Wilcannia ceases to be part of the regional NSW area at the beginning of 11 October 2021.

(2) Schedule 1, clause 3, table, item 1

Omit “, Central Darling”, “, Mid-Western Regional” and “, Walgett”.

(3) Schedule 1, clause 3, table, item 1, column 3

Omit “1 October 2021”. Insert instead “11 October 2021”.

(4) Schedule 1, clause 3, table
