ABORIGINAL LAND RIGHTS ACT 1983

NOTICE

I, the Honourable Ben Franklin MLC, Minister for Aboriginal Affairs, following approval by the New South Wales Aboriginal Land Council (NSWALC), do, by this notice pursuant to section 222(1) of the Aboriginal Land Rights Act 1983 (the Act), appoint Mr Tim Gumbleton to the Jubullum Local Aboriginal Land Council (Jubullum LALC), for a period of six calendar months. During the period of his appointment, the Administrator will have all the functions of Jubullum LALC, the Board of the Jubullum LALC, and the members of the Jubullum LALC exercised by resolution of the members of the Jubullum LALC, and subject to section 230 of the Act, and any other duties as specified by the agreed terms of appointment. The Administrator's remuneration and expenses are not to exceed \$14,200 excluding GST per month, without the prior approval of NSWALC. The Administrator's remuneration may include fees payable for the services of other personnel within the Administrator's firm who provide services as agents of the Administrator.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to AMES Australia to advertise, designate and recruit up to 15 frontline roles for Aboriginal and or Torres Strait Islander persons only in pursuit of a 3% Aboriginal and Torres Strait Islander workforce participation rate.

This exemption will remain in force for 5 years.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to AFL SportsReady Ltd to advertise, designate and recruit

- up to 60 traineeship, cadetship, and employment positions per year for Aboriginal and Torres Strait Islander persons only,
- the role of Aboriginal and Torres Strait Islander Mentor

This exemption will remain in force for 5 years.
