REGULATION OF VESSELS – EXCLUSION ZONE

Location

Tasman Sea adjoining Wollongong Harbour and waters within Wollongong Harbour defined by:

1. the shoreline adjacent to the intersection of Harbour Street and Cliff Road, to
2. the eastern side of the remnants of the stone structure adjacent to the Wollongong Slipway, to
3. the entrance into the Wollongong Harbour, to
4. a point extending approximately 50 metres off the continental pools and out to a point approximately 100 metres off the Southern Break wall into the Tasman Sea.

Duration

- 8.00am to 12.00pm – Saturday 10 December 2022

Detail

The swimming leg of a Aquathon will be conducted at the location specified above.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by the presence of course rounding buoys. The Zone will extend for 20 metres outside the course rounding buoys on all sides and will be monitored by event support vessels

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Lemon Tree Passage, Port Stephens – opposite the Lemon Tree Passage northern boat ramp

Duration

- 7.00pm to 9.45pm – Saturday 19 November 2022

Detail

A fireworks display will be conducted over the navigable waters of Lemon Tree Passage, Port Stephens specified above. Fireworks will be launched from a moored firing barge at the above location. The area directly around this firing position may be dangerous and hazardous to other waterway users while fireworks are being launched.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of control vessels stationed on the boundary, and will extend 150 metres around the moored barge.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.
