ORDER

Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* the Order that took effect on and from 13 July 2022, issued to **Mr Joe Nizar Kahlil (PHA0001617137)** of Rockdale NSW 2216, prohibiting him as a pharmacist from supplying or having possession of, or manufacturing any preparation, admixture or extract of a drug of addiction as authorised by clauses 101(1) and 102 of the Regulation, shall cease to operate on and from 6 December 2022.

Declaration of Treatment Centres

DECLARE the following premises as a treatment centre for the purposes of the Act with effect from 12 December 2022:

Inpatient Drug and Alcohol Services, Level 5, Douglas Building, Royal North Shore Hospital, Reserve Road, St Leonards NSW 2065.
