**BOMBING ISREALI CONSULATE AND JEWISH HAKOAH CLUB 23RD
DECEMBER 1982.**

ONE MILLION DOLLARS (\$1,000,000) REWARD

At 2pm on the 23rd of December 1982 a bomb exploded on level 7 of the Westfield Tower, 100 William Street Sydney directly in front of the Israeli Consulate. One volunteer from the Consulate was seriously injured, there were no fatalities. At 5.45pm the same day a second explosion occurred in the car park of the Jewish Hakoah Club at 61 Hall Street Bondi, there were no injuries or fatalities. This bomb has been linked to international terrorist organisation 'May 15'.

Investigation has indicated that both the bombs failed to cause the damage to property and person that was intended. The bomb at the consulate was placed incorrectly and the bomb at the Hakoah club malfunctioned.

Notice is hereby given that a reward of up to one million dollars (\$1,000,000) will be paid by the Government of New South Wales for information leading to the arrest and conviction of the person or persons responsible for the planning, preparation and/or deployment of the explosive device used to bomb the Israeli Consulate and Hakoah on 23rd December 1982.

The allocation of this reward will be at the sole discretion of the Commissioner of Police.
