GEOGRAPHICAL NAMES ACT 1966

PURSUANT to the provisions of Section 8 of the *Geographical Names Act 1966*, the Geographical Names Board hereby notifies that it proposes to assign the name:

Saunders Railway Station for a railway station located underground running parallel to Pitt Street with entrances from Park Street and Bathurst Street, Sydney, City of Sydney LGA.

The position and extent for this feature is recorded and shown within the Geographical Names Register of New South Wales. The proposal can be viewed and submissions lodged on the Geographical Names Board website at www.gnb.nsw.gov.au from 8 April to 11 May 2022. Alternatively, written submissions may be mailed to the Secretary, Geographical Names Board, 346 Panorama Ave, Bathurst, NSW 2795.

In accordance with Section 9 of the *Geographical Names Act 1966*, all submissions lodged may be subject to a Government Information (Public Access) application and may be viewed by a third party to assist the Board in considering this proposal.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8, 19 and 51 of the *Anti-Discrimination Act 1977* (NSW) to City of Parramatta Council to:

- advertise, designate and recruit the position of Keeping Place Officer for an Aboriginal or Torres Strait Islander person only; and
- provide access to sacred materials held at Keeping Place to Aboriginal and Torres Strait Islanders only.

This exemption will remain in force for 10 years.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to the NSW Aboriginal Land Council to advertise, designate and recruit roles for Aboriginal and Torres Strait Islander people only in pursuance of its goal of a 75% Aboriginal and Torres Strait Islander workforce participation rate.

This exemption will remain in force for 5 years.

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 25 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Finder Crew Pty Ltd to advertise, designate and recruit up to 15 technology graduate positions per year for women only.

This exemption will remain in force for 5 years.
