# Anti-Discrimination Act 1977

## EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8, 10, 25, 27, 49D, 49F, 49ZYB, 49ZYD and 51 of the *Anti-Discrimination Act 1977* (NSW) to Transport Cluster - comprising Transport for NSW, the State Transit Authority, Sydney Trains, NSW Trains, Sydney Metro Authority and Point to Point Commission to implement diversity and inclusion programs for designated target groups:

### 1. Women

- 1.1. Targeted support to women in preparation for recruitment processes;
- 1.2. Targeted recruitment of women into senior service roles;
- 1.3. Targeted recruitment of women into entry level employment programs including graduate programs, scholarship programs, traineeships and apprenticeships;
- 1.4. Targeted recruitment of women into Science, Technology, Engineering, Mathematics and Construction roles (STEMC) and other non-traditional roles;
- 1.5. Targeted recruitment of women into frontline service delivery roles;
- 1.6. Targeted development programs for women including targeted talent management programs, leadership development, coaching, shadowing and sponsorship development opportunities;
- 1.7. Capability development, mentoring and connecting programs for women leaders and potential leaders.

### 2. Aboriginal and Torres Strait Islanders

- 2.1. Targeted support for Aboriginal and Torres Strait Islanders in preparation for recruitment processes;

- 2.2. Targeted recruitment of Aboriginal and Torres Strait Islanders into senior service roles;
  - 2.3. Targeted recruitment of Aboriginal and Torres Strait Islanders into entry level employment programs including graduate programs, scholarship programs, traineeships and apprenticeships;
  - 2.4. Targeted recruitment of Aboriginal and Torres Strait Islanders into frontline service delivery roles;
  - 2.5. Targeted development programs for Aboriginal and Torres Strait Islanders including targeted talent management programs, leadership development, coaching, shadowing and sponsorship development opportunities;
  - 2.6. Capability development, mentoring and connecting programs for Aboriginal and Torres Strait Islanders leaders and potential leaders.
3. People with a specific disability
    - 3.1. Targeted support for people with a specific disability in preparation for recruitment processes;
    - 3.2. Targeted recruitment of person with a specific disability;
    - 3.3. Targeted recruitment of people with a specific disability into entry level employment programs including graduate programs, scholarship programs, traineeships and apprenticeships;
    - 3.4. Targeted recruitment of people with a specific disability into frontline service delivery roles;
    - 3.5. Targeted development programs for people with a specific disability including targeted talent management programs, leadership development, coaching, shadowing and sponsorship development opportunities;
    - 3.6. Capability development, mentoring and connecting programs for people with a specific disability at or post entry level employment programs and making the transition from such programs into roles within the Transport Cluster.
4. People under the age of 25
    - 4.1. Targeted support of people under the age of 25 in preparation for recruitment processes;

- 4.2. Targeted recruitment of people under the age of 25 into entry level employment programs including graduate programs, scholarship programs, traineeships and apprenticeships;
- 4.3. Targeted recruitment of people under the age of 25 into frontline service delivery roles;
- 4.4. Targeted development programs for people under the age of 25 including targeted talent management programs, leadership development, coaching, shadowing and sponsorship development opportunities.

This exemption will remain in force for 5 years.

## MURDER

### FIVE HUNDRED THOUSAND DOLLAR (\$500,000) REWARD

On 21 February 1997, the headless body of an unidentified male was located in Paddy's River, Penrose, NSW. The decapitated head of the male was later located on 28 March 1997 in Salt Pan Creek, Padstow NSW. A coronial inquest held in 1999 determined that the male died by strangulation on or about the 20 February 1997. The identity of the deceased male has never been established.

Notice is hereby given that a reward of up to five hundred thousand dollars (\$500,000) will be paid by the Government of New South Wales for information leading to identification of the unidentified male located in Paddy's River, Penrose, and Salt Pan Creek, Padstow in 1997 and/or for information leading to the arrest and conviction of the person or persons responsible for his murder.

The allocation of this reward will be at the sole discretion of the Commissioner of Police.

The urgent assistance and co-operation of the public is especially sought in the matter. Any information, which will be treated as confidential, may be given at any time of the day or night at any Police Station or by telephone-



## Venues New South Wales 2022 Election of Members Advisory Committee Members ELECTION NOTICE

Pursuant to the *Sporting Venues Authorities Amendment (Venues NSW) Act 2020* and the Regulation thereunder, Vero Voting will be the Returning Officer for the election of Members Advisory Committee.

### **Nominations**

Nominations are hereby invited for the Two Positions (2) of Members Advisory Committee. The positions are four (4)-year terms and commence on July 1<sup>st</sup>, 2022.

Nominations shall be conducted online and will need to be seconded by six (6) financial SCG members and by the candidate who shall signify his/her consent to the nomination. Candidates must be a voting SCG member which means a member of the Sydney Cricket Ground who is of a class prescribed by the regulations. No member may nominate more candidates than the number to be elected for each position.

Candidates must lodge a policy statement not exceeding 300 words, which you can enter via the online nomination portal. This candidate policy statement is submitted online when you submit or confirm your nomination.

### **Lodgement of Nominations and Candidate Statements**

Vero Voting will email to each eligible member a Unique Login that will allow them to lodge their Nominations. This will be emailed at the open of the Nomination period at 12.00 noon AEST on Friday 22<sup>nd</sup> April 2022.

Online Nominations must be received by the Returning Officer, Vero Voting by no later than 12.00 noon AEST on Friday 13<sup>th</sup> May, 2022. A candidate may only withdraw his/her nomination in writing to be received by the Returning Officer prior to the close of nominations.
