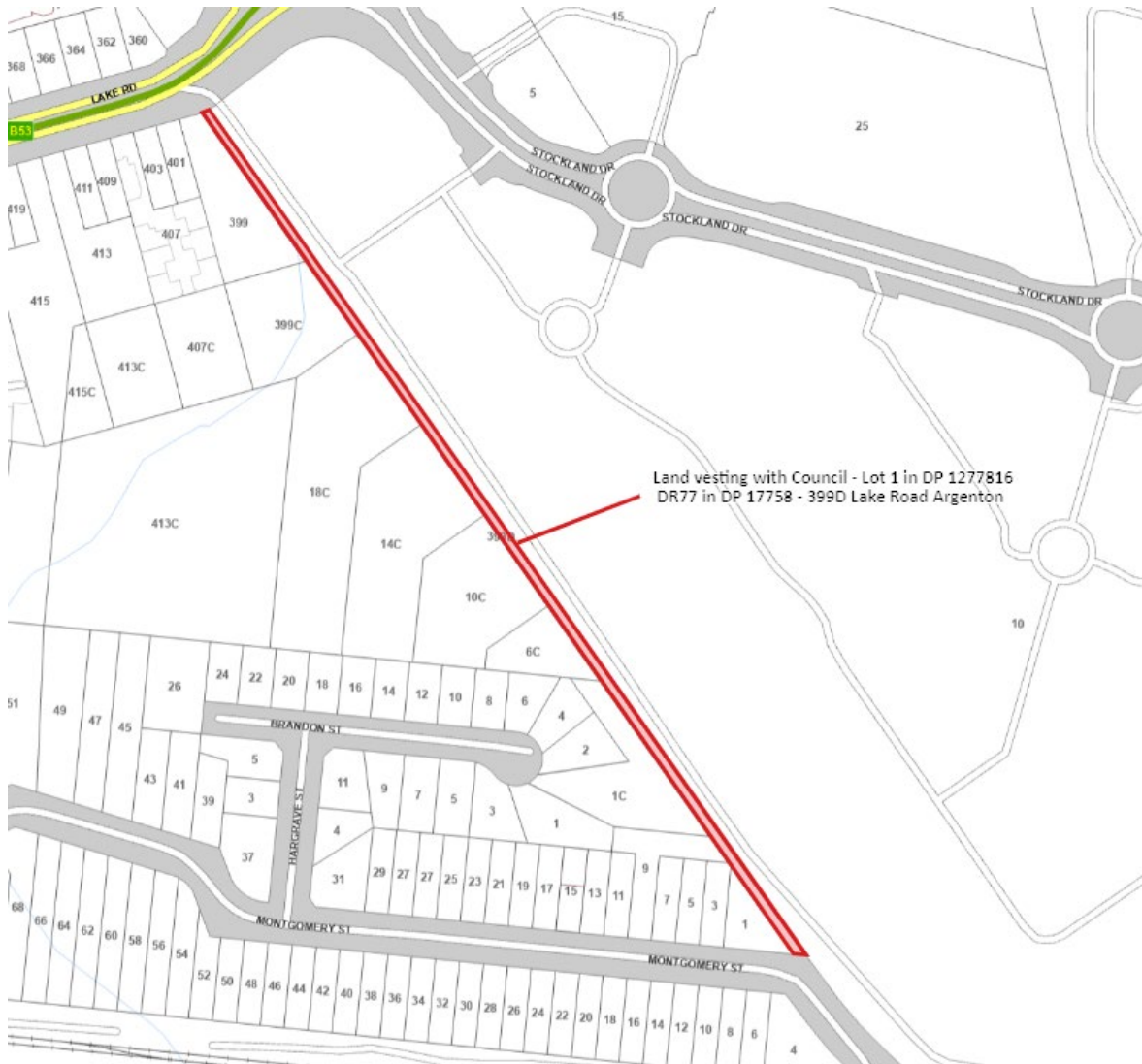

## ERRATUM

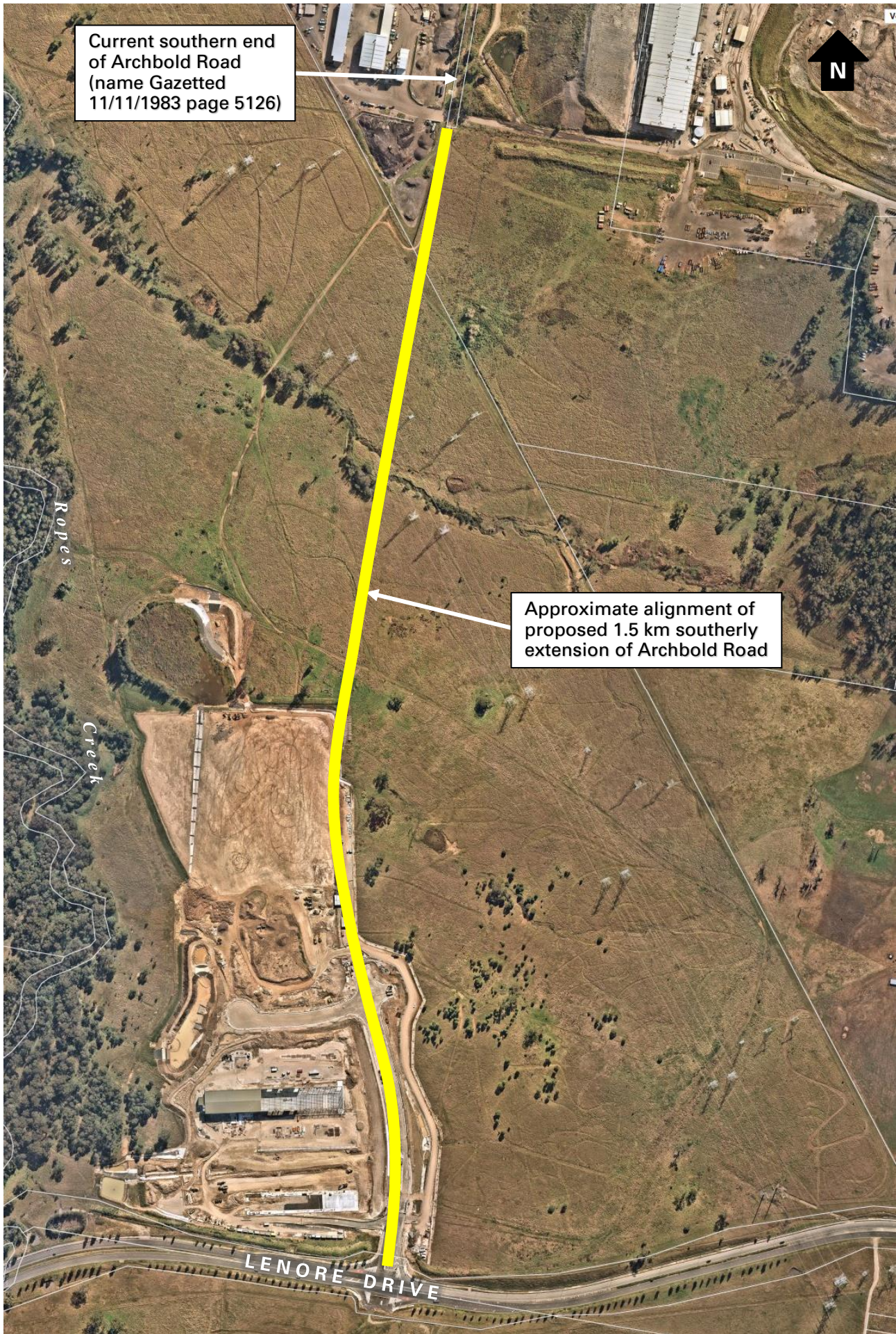
