Explanatory note

The object of this Order is to amend the *Public Health (COVID-19 Air and Maritime Arrivals) Order (No 1) 2022* to remove the quarantine requirements for unvaccinated international air and maritime arrivals.

Public Health (COVID-19 Air and Maritime Arrivals) Order (No 1) Amendment (No 2) Order 2022

1 Name of Order

This Order is the *Public Health (COVID-19 Air and Maritime Arrivals) Order (No 1) Amendment (No 2) Order 2022*.

2 Commencement

This Order commences at the beginning of 30 April 2022.

Schedule 1 Amendment of Public Health (COVID-19 Air and Maritime Arrivals) Order (No 1) 2022

- [1] **Clause 5 Quarantine period**
Omit the clause.
- [2] **Parts 2 and 3**
Omit the Parts.
- [3] **Part 4, heading**
Omit “**who are fully vaccinated arrivals**”.
- [4] **Clause 20 Introduction**
Omit “**who are fully vaccinated arrivals**”.
- [5] **Clause 20, notes**
Omit the notes.
- [6] **Clause 21, heading**
Omit “**Fully vaccinated arrivals**”. Insert instead “**Relevant international arrivals**”.
- [7] **Clauses 21 and 22**
Omit “**who is a fully vaccinated arrival**” wherever occurring.
- [8] **Parts 5 and 6**
Omit the Parts.
- [9] **Clause 35 Directions about information to police officers**
Omit the clause.
- [10] **Part 8, Division 1**
Omit the Division.
- [11] **Clause 41 Advice provided by Chief Health Officer**
Omit the clause.
- [12] **Schedule 1 Dictionary**
Omit the definitions of *approved COVID-19 vaccine, approved personal transportation, approved transportation, COVID-19 vaccine, essential task, fitted face covering, flight crew transport service provider, full day, fully vaccinated arrival, medical contraindication certificate, medical facility, NSW Health Guideline: Appropriate PPE for Maritime Workers, quarantine facility, quarantine period, quarantine person, unvaccinated overseas flight crew member, vaccination evidence* and *wharf*.
