Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to ReachOut Australia to advertise, designate and recruit positions for Aboriginal and Torres Strait Islander persons only to achieve a 7% Aboriginal and Torres Strait Islander workforce participation rate.

This exemption will remain in force for 10 years.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Northern Rivers Social Development Council Ltd trading as Social Futures to advertise, designate and recruit an Aboriginal Program Worker for an Aboriginal or Torres Strait person only.

This exemption will remain in force until June 2025.

Approved traffic courses for the Traffic Offender Intervention Program

Clause 104 of the Criminal Procedure Regulation permits the approval of a course of study or training as an approved traffic course for the purpose of the Traffic Offender Intervention Program (TOIP). Clause 104 further stipulates that this order must be published in the Gazette.
