Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* a direction has been issued that the Order that took effect on and from 25 June 2021, on **Mr Jason Michael Demyane (PHA0002242371)** of Five Dock NSW 2046, prohibiting him as a pharmacist from supplying or having possession of, or manufacturing any preparation, admixture or extract of a drug of addiction as authorised by clauses 101(1) and 102 of the Regulation, shall cease to operate on and from 16 May 2022.
