Delegation of Functions of Heritage Council of NSW

- I, Frank Howarth, Chairperson of the Heritage Council of NSW, in accordance with resolutions of the Heritage Council **7 July 2021** do by this instrument:
 - a) revoke the delegations made by the Heritage Council on 3 June 2016
 - b) **delegate** the Heritage Council's statutory functions set out in Columns 1 and 2 of Schedule A and B below to the persons in the delegate level or levels specified in Column 4 of Schedule A and B, subject to the limits specified in Column 3 of Schedule A and B.

Power under which this delegation is made

This delegation is made under section 169(3) and section 21 of the Heritage Act 1977.

Commencement

This instrument commences on the date on which the Minister gives consent pursuant to section 169(3), on the recommendation of the Heritage Council under section 21.

General limitation on the exercise of a delegated function

Where a delegated function relates to a financial matter, the function must be exercised in accordance with the financial delegations as authorised (from time to time by the Minister responsible for the *Heritage Act 1977*) and also in accordance with any directions made under the *Public Sector and Audit Act 1983* (NSW) and the *Government Sector Finance Act 2018* (NSW).

Definitions and Abbreviations

In the absence of the Chair, or where a conflict of interest arises, the Deputy Chair shall perform the duties and exercise the authority of Chair in relation to all proceedings of the Heritage Council;
- (i) Environment Officer Level 9 (or equivalent role) means the person or persons appointed from time to time (in a permanent, temporary or acting capacity) in the position of Officer/ Environment Officer Class 9 of Heritage NSW, Department of Planning and Environment (or the equivalent);
- (j) Environment Officer Level 10 (or equivalent role) means the person or persons appointed from time to time (in a permanent, temporary or acting capacity) in the position of Senior Officer/ Environment Officer Class 10 of Heritage NSW, Department of Planning and Environment (or the equivalent);
- (k) Environment Officer Level 12 (or equivalent role) means the person or persons appointed from time to time (in a permanent, temporary or acting capacity) in the position of Senior Team Leader, Environment Officer Level 12 of Heritage NSW, Department of Planning and Environment (or the equivalent);
- (I) Environment Officer Level 14 (or equivalent role) means the person or persons appointed from time to time (in a permanent, temporary or acting capacity) in the position of Manager/ Environment Officer Level 14 of Heritage NSW, Department of Planning and Environment (or the equivalent);
- (m) EP&A Act means the Environmental Planning and Assessment Act 1979;
- (n) **Functions** has the same meaning as the term in section 4, *Heritage Act 1977*;
- (o) **Heritage Council** means the Heritage Council constituted under section 7, *Heritage Act* 1977:

- (p) **Heritage NSW** is a branch within the Department of Planning and Environment see Schedule 2, 3: Other Public Service Agencies, *Administrative Arrangements (Second Perrottet Ministry—Allocation of Acts and Agencies) Order 2021*;
- (q) **Historic Shipwreck** has the same meaning as the term in section 47, *Heritage Act 1977*;
- (r) **IHO** means an 'interim heritage order' as defined under section 4, *Heritage Act 1977*;
- (s) **Item** has the same meaning as the term in section 4, *Heritage Act 1977*;
- (t) **Local heritage significance** has the same meaning as the term in section 4A, *Heritage Act 1977;*
- (u) **Material Threshold** is described in sections 61(1) and 63(3)c of the *Heritage Act 1977*, where there is a material affect that impacts the exercise of a function to give public notice of an application or determine an application for approval;
- (v) Material Threshold Policy 2020 is a Heritage NSW policy (amended from time to time);
- (w) **Relic** has the same meaning as the term in section 4, *Heritage Act 1977;*
- (x) Senior Executive Band 1 (or equivalent role) means the person or persons appointed from time to time (in a permanent, temporary or acting capacity) in the position of Director/ Senior Executive Band 1 at Heritage NSW, Department of Planning and Environment (or the equivalent);
- (y) Senior Executive Band 2 (or equivalent role) means the person appointed from time to time (in a permanent, temporary or acting capacity) in the position of Executive Director/ Senior Executive Band 2 of Heritage NSW, Department of Planning and Environment (or the equivalent);
