Penrith Stadium Redevelopment Project
Project Authorisation Order

I, Rob Stokes, MP, Minister for Infrastructure, Minister for Cities and Minister for Active Transport:

1. **NOMINATE** the Penrith Stadium Redevelopment Project as a major infrastructure project for the purposes of the *Infrastructure NSW Act 2011 No. 23*.
2. **AUTHORISE** Infrastructure NSW, pursuant to sections 30 and 31 of the *Infrastructure NSW Act 2011 No. 23*, to carry out the Penrith Stadium Redevelopment Project.
3. **DECLARE**, pursuant to section 32 of the *Infrastructure NSW Act 2011 No. 23*, Infrastructure NSW to be responsible for any functions of the Office of Sport within the Department of Enterprise, Investment and Trade and Venues NSW, insofar as those functions relate to the Penrith Stadium Redevelopment Project.

In this order:

Site means the land in Lot 1/DP 1147219, Lot 2/DP1147219 and Lot 12/1176987.

Penrith Stadium Redevelopment Project means, on the Site at Penrith, demolition of existing buildings and facilities, repurposing of existing buildings and facilities, carrying out infrastructure, works, services and facilities and the design, construction and delivery of a new stadium with a capacity of up to 25,000 on the Site, together with all ancillary relocations, buildings, car parks, infrastructure, works, services and facilities, training facilities, connections and interfaces with surrounding infrastructure and developments.
