#### Section 12

# **REGULATION OF VESSELS – SPECIAL RESTRICTION**

# Location

Hawkesbury River, Spencer to Windsor

# **Background**

Flooding due to heavy rain is presenting a risk to the safety of navigation, and as a result special restrictions are declared for the waters of the Hawkesbury/Nepean River and tributaries.

# **Duration**

24 hours on the following days:

Tuesday 5 July to Monday 8 July 2022

# **Detail**

A restriction pursuant to section 11 of the Marine Safety Act 1998 is declared to be in place at the location for the duration specified above. The restriction is applicable to all vessels (including personal watercraft) and applies and takes precedence over any localised signage.

# **Special Restriction:**

Pursuant to Section 12(3) of the Marine Safety Act 1998

- A maximum speed limit of **15 knots** must be adhered to at all times.
- No towing is permitted.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

# **REGULATION OF VESSELS – EXCLUSION ZONE**

#### Location

Trial Bay, South West Rocks - approximately 200 metres wide by 400 metres offshore close to the entrance of Saltwater Creel and South West Rocks Surf Club.

#### **Duration**

6.00am to 5.00pm on the following dates:

Friday 8, Saturday 9 and Sunday 10 July 2022

# **Detail**

A Surf Life Saving event will be conducted on the navigable waters described above.

An **EXCLUSION ZONE** is specified during the event, which will be marked by a series of buoys.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone, which will be monitored by control vessels.

Penalties may apply (section 12 (5) - Marine Safety Act 1998)
