Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* a direction has been issued that the Order that took effect on and from 4 March 2020, on **Ms Tramanh Kieu Nguyen (PHA0001662910)** of Earlwood NSW 2206, prohibiting her as a pharmacist from supplying or having possession of, or manufacturing any preparation, admixture or extract of a drug of addiction as authorised by clauses 101(1) and 102 of the Regulation, shall cease to operate on and from 15 July 2022
