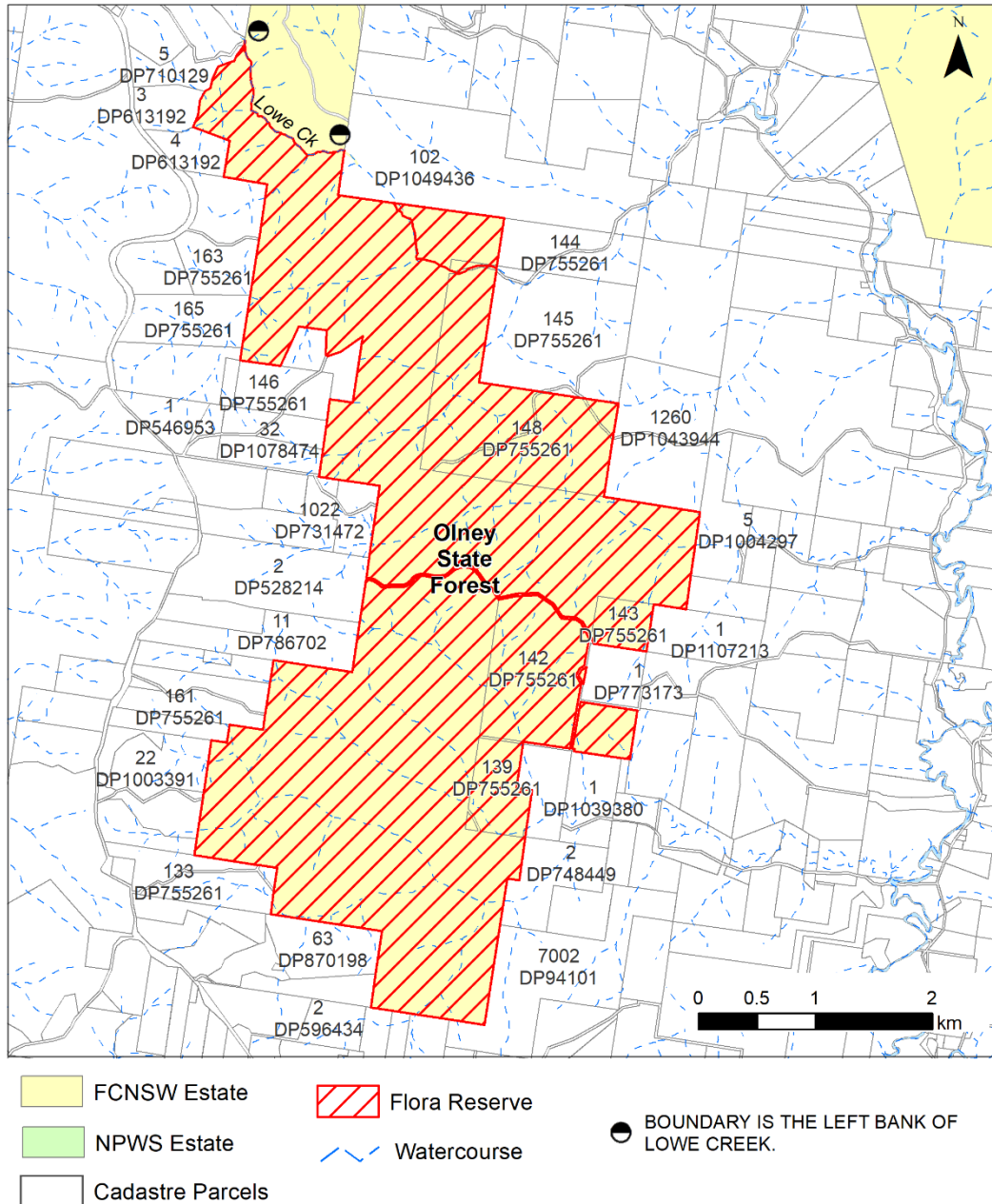

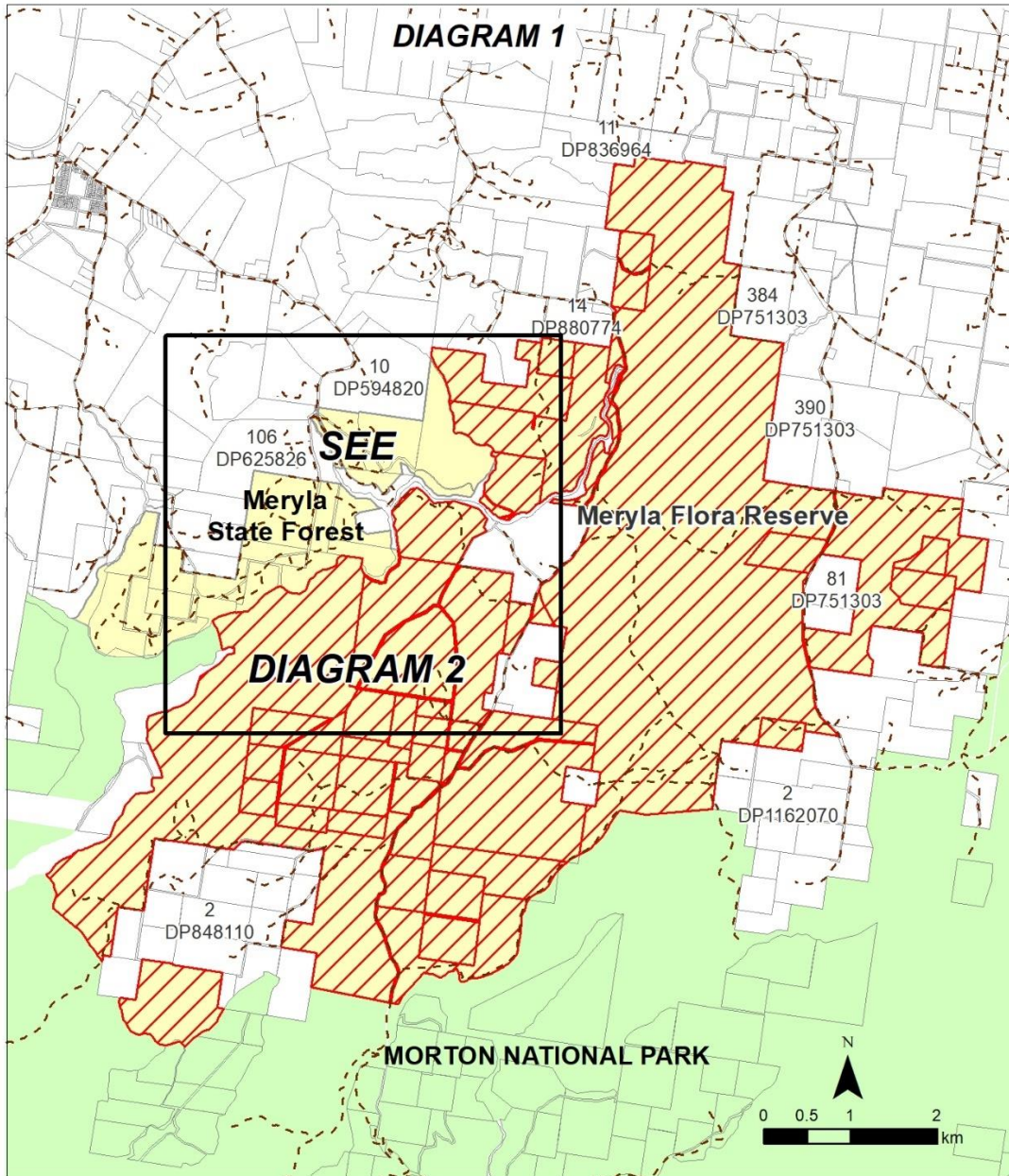

FORESTRY ACT 2012

NOTICE REVOKING SPECIAL MANAGEMENT ZONES AND SETTING APART FLORA RESERVES 2022

I, the Honourable Margaret Beazley AC QC, Governor of the State of New South Wales, pursuant to sections 16 and 20(1) of the *Forestry Act 2012*:

- (1) revoke the declarations of special management zones in State forests for the areas of land described in Schedules 1 to 3 to this notice, and

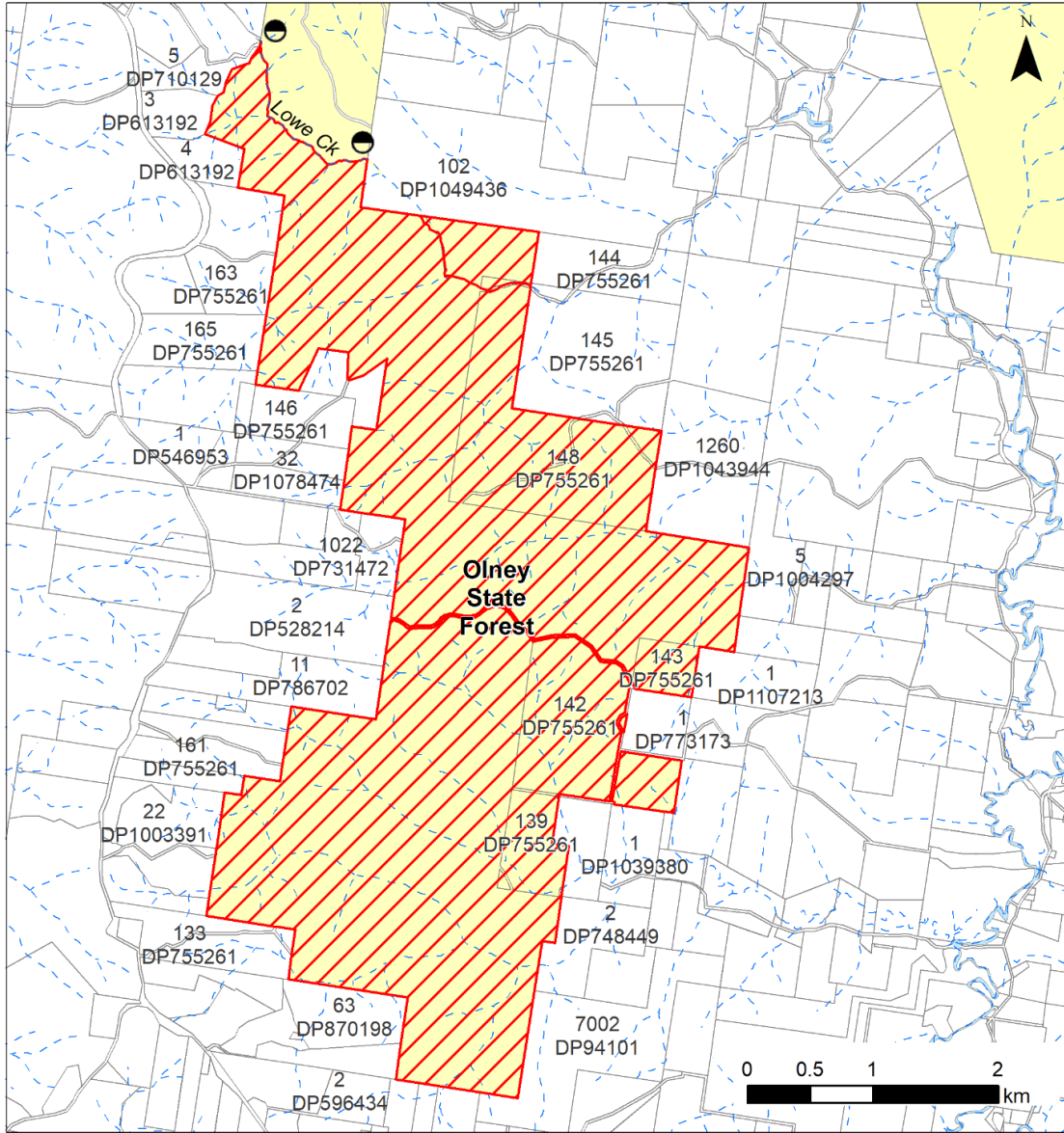

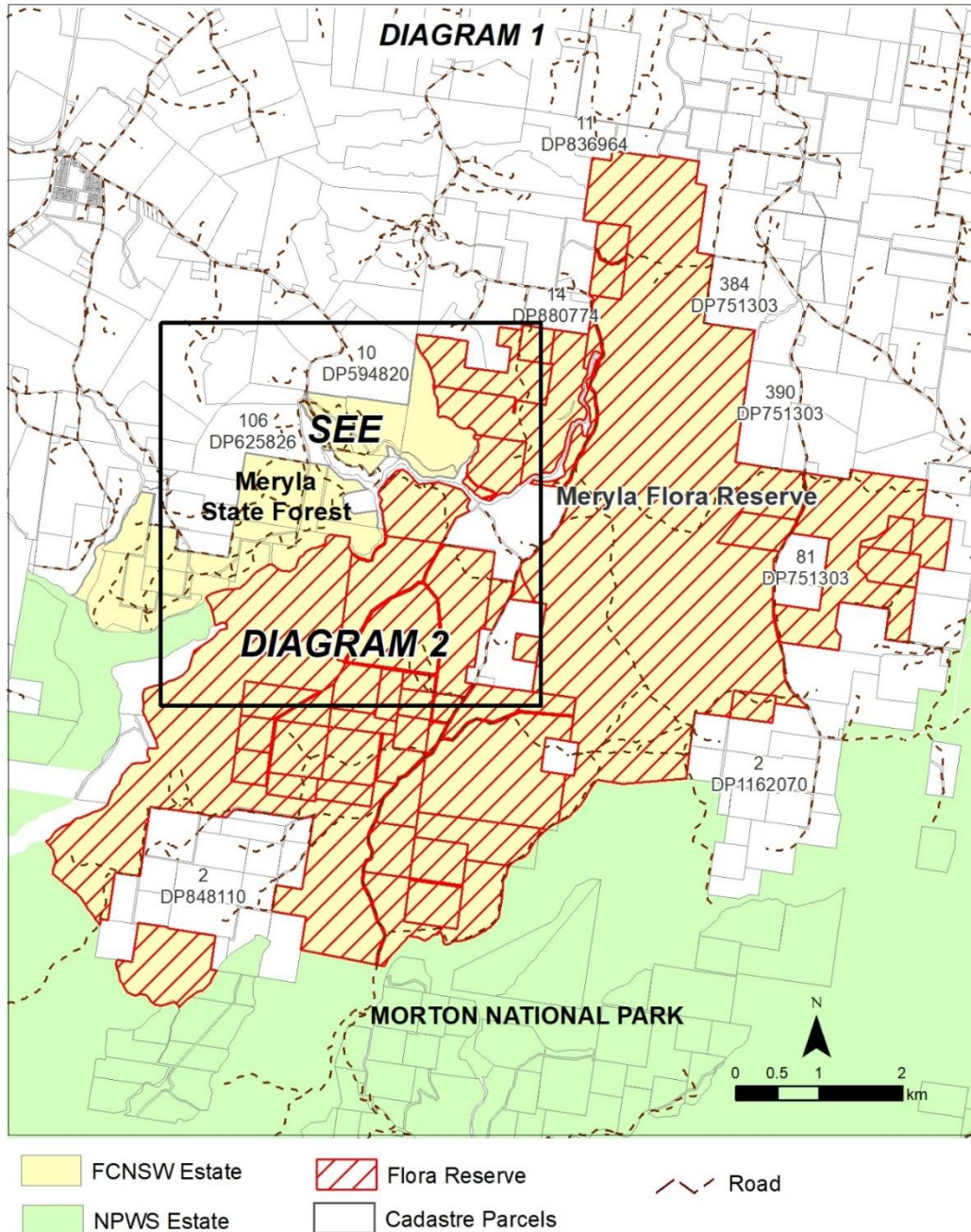

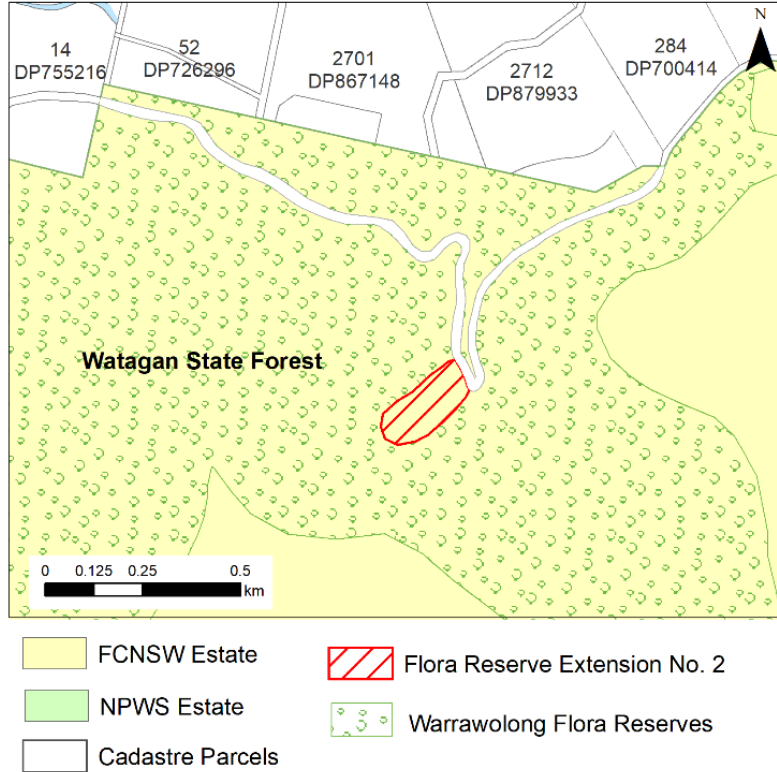
