REGULATION OF VESSELS - EXCLUSION ZONE

Location

Tweed River - between Stotts Island and Condong Bridge (Saturday 6 August 2022)

Tweed River - Fingal to Murwillumbah (Sunday 7 August 2022)

Duration

- 12.00pm to 4.00pm Saturday 6 August 2022
- 7.30am to 1.30pm Sunday 7 August 2022

Detail

Competitive water ski races will be conducted on the navigable waters of the Tweed River at the locations and times specified above, involving the use of high speed power vessels, persons being towed at speed using towlines, and persons in the water from time to time presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be indicated by the presence of support vessels along the perimeter.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998)
