MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, BRENDAN FLYNN, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:
- (a) DECLARE the following premises to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:
 - Newcastle Child and Adolescent Community Mental Health Service, located at 621 Hunter Street, Newcastle NSW 2300; and
- (b) DECLARE this facility to be designated as a "community or health care agency" class facility; and
- (c) RESTRICT this facility to the provision of services and performance of functions necessary for, or associated with, the administration or management of community treatment orders under the following provisions of the *Mental Health Act 2007*:
 - i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);
 - ii. Chapter 4; and
 - iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2).

MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, BRENDAN FLYNN, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007* and section 43 of the *Interpretation Act 1987*, DO HEREBY:
- (a) REVOKE the Order published in the NSW Government Gazette No. 666 of 24 December 2021 (no 2021-2873), declaring three Child and Adolescent Community Mental Health Services to be declared mental health facilities in accordance with section 109 of the *Mental Health Act 2007*; and
- (b) REVOKE the Order published in the NSW Government Gazette n2022-1631 of 19 August 2022, declaring the Hunter Valley Mental Health Service to be a declared mental health facility in accordance with section 109 of the *Mental Health Act 2007;* and
- (c) DECLARE the following premises to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:
 - Hunter Valley Adult and Child and Adolescent Community Mental Health Service, located in the Old Maitland Mental Health Unit within the Old Maitland Hospital campus at 560 High Street, Maitland NSW 2320; and
- (d) DECLARE this facility to be designated as a "community or health care agency" class facility; and
- (e) RESTRICT this facility to the provision of services and performance of functions necessary for, or associated with, the administration or management of community treatment orders under the following provisions of the *Mental Health Act 2007:*
 - i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);

ii. Chapter 4; and

iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2).
