- (a) Goulburn Mulwaree as described by Proclamation in Government Gazette No. 62 of 24 June 2011, and
- (b) Queanbeyan-Palerang Regional as described by the *Local Government* (Council Amalgamations) Proclamation 2016-

by transferring the land described in Schedule A from the Queanbeyan-Palerang Regional local government area to the Goulburn Mulwaree local government area and transferring the land described in Schedule B from the Goulburn Mulwaree local government area to the Queanbeyan-Palerang Regional local government area so that the boundaries of the area of-
