Lake Talbot, Narrandera – specifically the body of water extending from Lake Talbot Swimming Pool Complex up to the mud-bank opposite Snake Island.

**Detail**

A competitive water ski tournament will be conducted on the navigable waters of Lake Talbot, Narrandera specified above. The event will involve the use of high-speed power vessels, persons being towed at speed using towlines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

**ROADS ACT 1993 – ORDER**

The Honorable Margaret Beazley AC KC, Governor.

I, the Honorable Margaret Beazley AC KC, Governor of the State of New South Wales, with the advice of the Executive Council, and pursuant to the definition of approved toll camera in section 250A of the *Roads Act 1993*, do, by this Order, approve the type of digital camera named in Schedule 1 as being designed to take a photograph of a vehicle as it is driven past a toll point and to record on the photograph the matters specified in that definition.
