NSW Admission Board Amendment Rule 2023

Explanatory note

The object of this rule removes the requirement for an application for relaxation to be made directly to the Examinations Committee.

1 Name of Rule

This Rule is the NSW Admission Board Amendment Rule 2023.

2 Commencement

This Rule commences on 6 October 2023 and is required to be notified on the NSW legislation website.

3 Amendment of NSW Admission Board Rules 2015

Rule 67

Omit the Rule. Insert instead:

67

(1) A person excluded by rule 64, rule 65 or rule 66 may apply to the Executive Officer for a relaxation of the Rules.

(2) (omitted)

(3) The Executive Officer may, in circumstances which he or she regards as sufficiently special and upon such conditions as it or he or she thinks fit, relax rule 64, rule 65 or rule 66.



Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 25 and 51 of the *Anti-Discrimination Act 1977* (NSW) to ALDI Stores (A Limited Partnership) to advertise, designate and recruit for women only for executive manager level, managing director level, group director level and director level roles in pursuance of a 40% workforce participation rate for managerial and senior leadership roles and to implement leadership development, mentoring and networking programs for women only.

This exemption will remain in force for 5 years.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Westpac Banking Corporation to:

- Designate, advertise and recruit roles for Aboriginal and Torres Strait Islander persons only in pursuit of a 3 % workforce participation rate by 2028,
- Prioritise extending permanent employment offers to Aboriginal and Torres Strait Islander individuals who possess the requisite skills or attributes including participants in the Indigenous traineeship or internship programs for Aboriginal and Torres Strait Islander persons only.

This exemption will remain in force for 10 years.
