CHARITABLE TRUSTS ACT 1993

NOTICE UNDER SECTION 12

CY PRES SCHEME RELATING TO THE DR CHARLOTTE LAST PRIZE

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

This submission considers the Dr Charlotte Last Memorial Prize, which is currently valued at \$184,069, which was established in 1997 by an *inter vivos* gift from Minivolt Pty Ltd (**Minivolt**) to the University of Sydney (**the University**).

The terms require a candidate to be undertaking a Bachelor of Medicine and Bachelor of Surgery (**MBBS**) and a research project in either Paediatrics, Obstetrics and Gynaecology, Surgery or Neurosciences with a preference given to projects relating to premature births, orthopedic surgery and epilepsy. However, in 2014 the undergraduate degree of MBBS was replaced with the postgraduate degree of Doctor of Medicine. Therefore, the original terms of the trust have become impossible to fulfil.

The University holds the gift from Minivolt on an express trust for the purpose of awarding a scholarship. Trusts for the establishment and award of prizes and scholarships for students at educational institutions or for study in a recognised field, such as medicine, are charitable.

A cy pres scheme is required to remove the requirement that a candidate must be enrolled in a MBBS and replaced with the requirement that the candidate be undertaking a postgraduate degree and a research project in either Paediatrics, Obstetrics & Gynaecology, Surgery or Neurosciences, provided that the project is of sufficient merit. Preference will be given to projects relating to premature births, orthopaedic surgery and epilepsy.

In these circumstances, the Solicitor General, as the Attorney General's delegate has approved the establishment of a cy pres scheme whereby the requirement that the candidate for the Prize must be undertaking a MBBS at the University is removed and replaced with the requirement that a candidate of the Scholarship is undertaking a research project in either Paediatrics, Obstetrics & Gynaecology, Surgery or Neurosciences.

Pursuant to section 12 of the Charitable Trusts Act 1993, I hereby order that a cy pres scheme be established whereby the requirement that the candidate for the Prize must be undertaking a MBBS at the University is removed and replaced with the requirement that a candidate of the Scholarship is undertaking a research project in either Paediatrics, Obstetrics & Gynaecology, Surgery or Neurosciences.

The order will take effect 21 days after its publication in the NSW Government Gazette, in accordance with section 16(2) of the Charitable Trusts Act 1993.

ABORIGINAL LAND RIGHTS ACT 1983

NOTICE

I, the Honourable David Harris MP, Minister for Aboriginal Affairs and Treaty, following approval by the New South Wales Aboriginal Land Council (NSWALC), do, by this notice pursuant to section 222(1) of the Aboriginal Land Rights Act 1983 (the Act), and sections 36(3) and 48(1) of the Interpretation Act 1987, extend the appointment of Mr Timothy Gumbleton as Administrator to Red Chief Local Aboriginal Land Council (the Red Chief LALC), for a period of 6 calendar months, effective from 14 September 2023. Work Health and Safety Regulation 2017 Exemption No. 010/23

1. Name of Exemption

This Exemption is the Work Health and Safety Regulation 2017, Exemption No. 010/23.

2. Commencement

This Exemption commences on 1 January 2024 and has effect until 31 December 2029

3. Exemption

This Exemption is made by SafeWork NSW on its own initiative.

This Exemption applies to a PCBU to whom Order No. 43 applies.

A PCBU to whom Order No. 43 applies is exempt from compliance with clause 58(2) of the Regulation.

This Exemption is subject to the conditions specified in the Schedule.

4. Definitions

For the purposes of this Exemption:

Act means the *Work Health and Safety Act 2011*

Order No. 43 means the *Coal Services Health Monitoring Requirements for Coal Mine Workers Order No. 43* under the Coal Industry Act 2001 (the Order)

PCBU means a person conducting a business or undertaking within the meaning of the Act

Regulation means the *Work Health and Safety Regulation 2017*.

Schedule

This Exemption is subject to the following conditions:

1. The PCBU must at all times be fully compliant with paragraph 6, 8 and 10 of Order No. 43 (requirements for pre-placement, periodic and exit medical assessments) in respect of hearing assessments including audiometry to be conducted.
2. Nothing in this Exemption affects any other applicable requirement imposed by law on a PCBU in relation to matters relating to this Exemption, including the monitoring of workers and conditions at the workplace under section 19(3)(g) of the Act.



Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Southern Cross University to conduct targeted recruitment and development programs and designate and recruit up to 80 positions for Aboriginal and Torres Strait Islander persons only.
