# ***DANGEROUS GOODS (ROAD AND RAIL TRANSPORT) ACT 2008***

### **1. Name of Exemption**

This Exemption is the *Dangerous Goods (Road and Rail Transport) Act 2008 Exemption No. 013/23*.

### **2. Commencement**

This Exemption commences on 27 October 2023 and is valid until 8 December 2023 unless otherwise varied or cancelled.

### **3. Definitions**

In this Exemption;

**acid waste** means the dangerous goods classified UN 2308 NITROSYLSULPHURIC ACID, LIQUID or UN 3456 NITROSYLSULPHURIC ACID, SOLID and stored in 34 composite intermediate bulk containers (IBC) at the Spartrans site as at 11 October 2023.

**Avcon** means Avcon Projects Australasia Pty Ltd (ABN: 15 614 368 660)

**Spartrans site** means the facility located at 56 Jones Street, Pendle Hill, New South Wales.

**Cleanaway site** means the facility located at 47 Raven Street, Kooragang Island, New South Wales.

**Exempt persons** means consignors and packers employed or engaged by Avcon

#### 4. Exemption

- a) This Exemption is made by SafeWork NSW, a Competent Authority, on application from Avcon pursuant to subsection 42(1) of the *Dangerous Goods (Road and Rail Transport) Act 2008*.
- b) This Exemption applies to exempt persons, exempting them from compliance with the following clauses of the *Dangerous Goods (Road and Rail Transport) Regulation 2022*, in relation to the packaging of acid waste at the Spartrans site:
  - i. Clause 55 – Consignor's duties
  - ii. Clause 56 – Packer's duties
- c) This Exemption applies only to acid waste loaded, consigned and transported by Avcon from the Spartrans facility to the Cleanaway facility.
- d) This Exemption is subject to the conditions specified in Schedule 1.
- e) This Exemption applies in New South Wales.

### SCHEDULE 1

This Exemption is subject to the following conditions:

- 1) Avcon must ensure that containers of acid waste are checked for holes and leaks within 24 hours preceding the vehicle leaving the Spartrans facility. Acid waste must not be consigned for transport if a hole or a leak is detected in any container.
- 2) Avcon must ensure that prior to loading on a vehicle, containers of acid waste that are missing parts of their rigid outer casing are fitted with a physical barrier capable of protecting the inner plastics receptacle from impact and other forces associated with the normal conditions of transport.
- 3) Avcon must ensure that Acid waste are prepared, loaded, consigned and transported in accordance with the Avcon JSA/SWMS document titled "Load and transport of compromised IBCs in DG Container", dated 3 October 2023.
- 4) Avcon must ensure that on each occasion that the acid waste is to be transported, notification of the intended date and time of transport is given to SafeWork NSW, EPA NSW and Fire and Rescue NSW at least three business days prior to the acid waste being consigned for transport, at the following contact details:

  - c) Fire & Rescue NSW by email to [trent.brown@fire.nsw.gov.au](mailto:trent.brown@fire.nsw.gov.au)
- 5) Avcon must ensure that transport of acid waste starts and finishes outside the hours of 8 am to 8 pm.
- 6) Avcon must ensure that transport of acid waste must occur in a direct route from the Spartrans site to the Cleanaway site without stopping, unless stopping is required to comply with another law or for an emergency.
- 7) Avcon must ensure that the vehicle transporting acid waste must be accompanied by an emergency response vehicle containing personnel and equipment capable of providing immediate emergency assistance in case of a spill or other incident involving the acid waste during transport.
- 8) A copy of this Exemption must be provided by the consignor to the driver to be carried during transport of the acid waste.



**CHARITABLE TRUSTS ACT 1993**

**NOTICE UNDER SECTION 12**

**CY PRES SCHEME RELATING TO THE DR CHARLOTTE LAST PRIZE**

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

The Special Purpose and Trust ('**SPT**') Account 433126 and SPT Account 433098 are operated by Western Sydney Local Health District ('**WSLHD**'), and are currently valued at \$19,638.93 and \$16,266, respectively.

The SPT Account 433126 was established by donations directed to the Medical Physics Department at Westmead Hospital. The SPT Account 433098 was established by donations and other sources of funding for 'research, staff development and equipment'.

The documentation regarding the purposes of SPT Account 433126 is inconsistent and leaves doubt as to the exact ambit of the intended purpose of the fund. Similarly, the stated purpose of SPT Account 433098 is vague. As such, each trust presents a risk to the proper use of the trust property, and as the original purposes are vague, poorly documented and have significant overlap, they have ceased to provide a suitable and effective method of using the trust property.

Trusts for the advancement of medical education, medical research and the 'general improvement of the medical art' are charitable as they fall within the charitable head of advancement of education.

A cy pres scheme is required to amalgamate the trust property of SPT Account 433126 and SPT Account 433098 into a single fund. The proposed scheme will have a new purpose being 'education in the field of medical physics, including staff development, research and training.' Given the trusts will continue to be for education in the field of medical physics, the proposed new trust purpose is sufficiently close to the original purposes of each of the trusts.

In these circumstances, the Solicitor General, as the Attorney General's delegate, has approved the establishment of a cy pres scheme to amalgamate the two separate funds for a singular purpose.

Pursuant to section 12 of the *Charitable Trusts Act 1993*, I hereby order that a cy pres scheme be established whereby the trust property of SPT Account 433126 and SPT Account 433098 is amalgamated and applied by Western Sydney Local Health District for the new purpose of 'education in the field of medical physics, including staff development, research and training'.

The order will take effect 21 days after its publication in the NSW Government Gazette, in accordance with section 16(2) of the Charitable Trusts Act 1993.
