## GEOGRAPHICAL NAMES ACT 1966

PURSUANT to the provisions of Section 8 of the *Geographical Names Act 1966*, the Geographical Names Board hereby notifies that it proposes to assign the name:

***Ganangdayi*** as a dual name for the geographical feature already named Macdonald River.

Macdonald river commences on the eastern slopes of Mellong Range about 9 km Northwest by West of Kindarun Mountain. It flows generally East by South then South for approximately 120 km into the Hawkesbury River at Wisemans Ferry.
