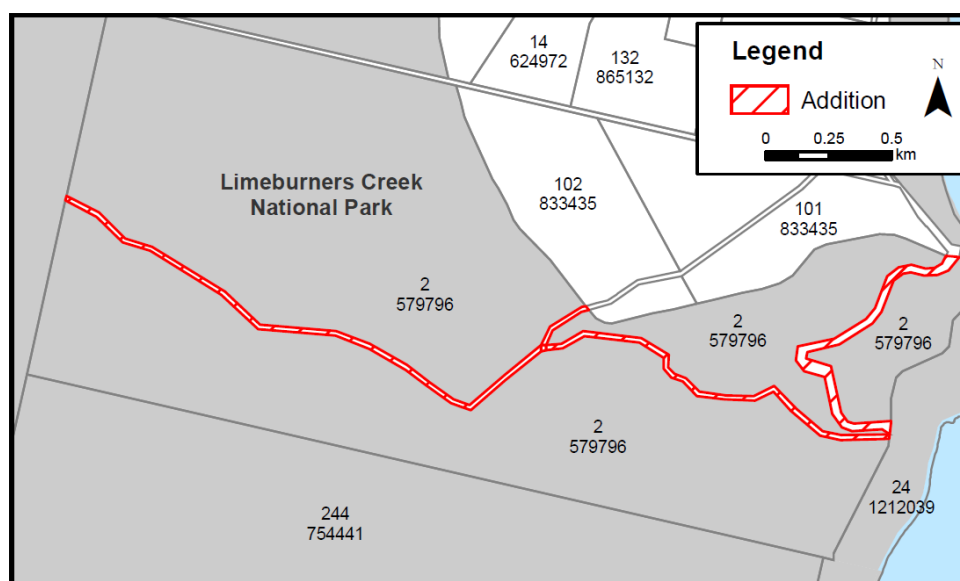

## Variation of Declaration of Wilderness Area

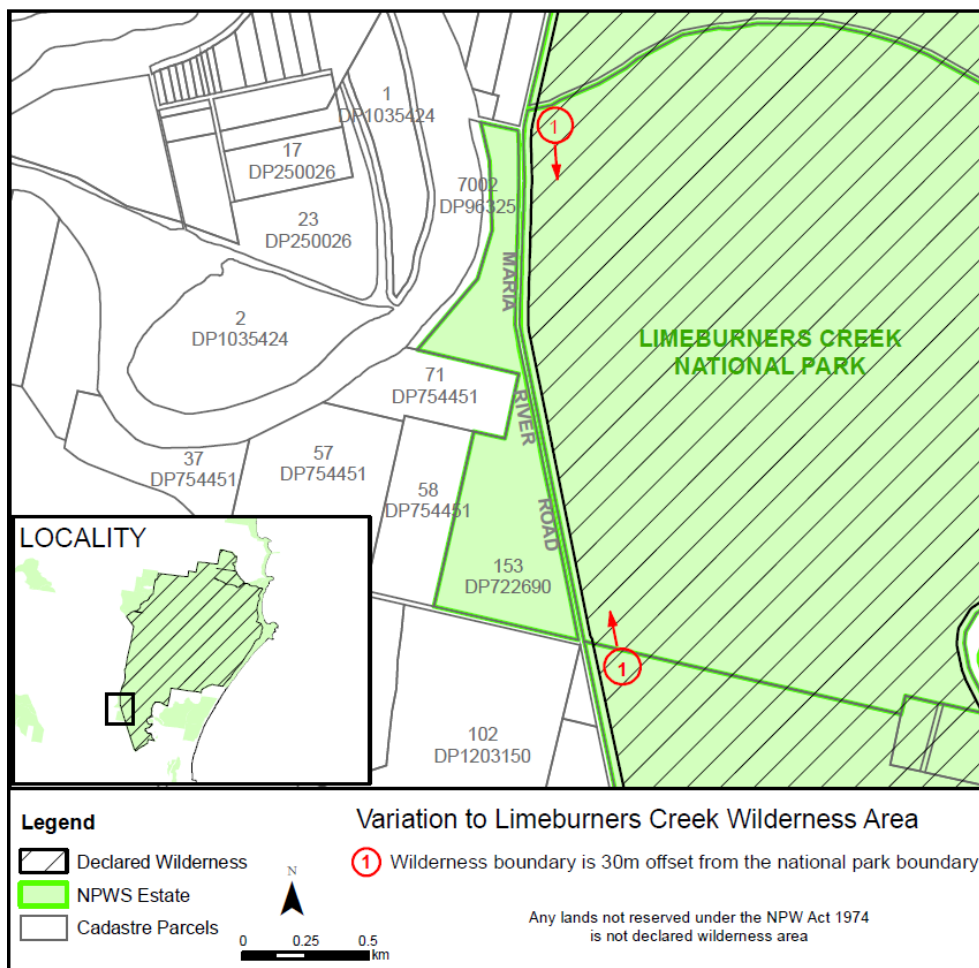
In pursuance of the powers vested in me under Section 8 (4A) of *Wilderness Act 1987*, I hereby declare that the declaration of part of the **Limeburners Creek Wilderness** under the provisions of Section 8 (1A) of the *Wilderness Act 1987*, by notification in the Government Gazette of 21 March 2003 folio 4209 and 4211, is varied by redefining part of the wilderness area to be as shown in Schedule 1 below.
