Tweed Shire Council has prepared the Tweed River Estuary: Coastal Management Program 2022 – 2032 and received certification by the Minister under Section 17(2) of the *Coastal Management Act 2016*. The Tweed River Estuary: Coastal Management Program 2022 – 2032 provides an updated plan to direct the ongoing management of the estuary, address NSW coastal management reforms, establish the strategic land use planning framework, and supports the implementation of the management objectives of the *Coastal Management Act 2016*.
