Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008*, the Order that took effect on and from 17 June 2022, on **Mrs Alica Lo Gabila** of Birrong NSW 2143, prohibiting her as a pharmacist from supplying or having possession of, or manufacturing any preparation, admixture or extract of a drug of addiction as authorised by clauses 101(1) and 102 of the Regulation, shall cease to operate on and from **3 February 2023**.

Explanatory note

The object of this Order is to set the rate of compensation payable to an injured worker in respect of the cost of travel associated with treatment by private motor vehicle under Section 64 of the *Workers Compensation Act 1987 Act*.

Workers Compensation (Car Travel Allowance) Order 2023.

1. Name of Order

This Order is the *Workers Compensation (Car Travel Allowance) Order 2023*.

2. Commencement

This Order commences on 1 March 2023.

3. Rate for travel by private motor vehicle

For the purposes of section 64 (b) of the *Workers Compensation Act 1987*, the cost of, or an amount for, travel by private motor vehicle as referred to in that section is to be calculated:

- a) in the case of travel on or after 30 June 1987 and before 18 May 1990 – at the rate of 28 cents per kilometre, or
- b) in the case of travel on or after 18 May 1990 and before 1 July 2000 – at the rate of 38 cents per kilometre, or
- c) in the case of travel on or after 1 July 2000 and before 1 October 2005 – at the rate of 42 cents per kilometre, or
- d) in the case of travel on or after 1 October 2005 and before 1 March 2023 – at the rate of 55 cents per kilometre, or
- e) in the case of travel on or after 1 March 2023 – at the rate of 58 cents per kilometre.

4. Repeal

The *Workers Compensation (Car Travel Allowance) Order 2005* is repealed.
