Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the Anti-Discrimination Act 1977 (NSW), an exemption is given from sections 25, 31A and 51 of the Anti-Discrimination Act 1977 (NSW) to University of New South Wales to offer, advertise and facilitate scholarships (PhD/HDR, Coursework) and fellowships for women in the fields of science, technology, engineering, mathematics and medicine (STEMM), economics, finance and business (EFAB), the built environment, as well as other programs where the percentage of commencing women enrolments is below 40%.

This exemption will remain in force for 5 years.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 25 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Suncorp Group Limited and its wholly owned subsidiaries to enable it to advertise, designate and recruit for up to 5 information technology internships per year for women only.

This exemption will remain in force for 5 years.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Bathurst Regional Council to designate, recruit and employ an Aboriginal and/or Torres Strait Islander person only as a trainee Environmental Health Officer (EHO).

This exemption will remain in force for 8 years.
