ROADS ACT 1993

Sections 46

On the recommendation of Transport for NSW pursuant to section 54 of the *Roads Act 1993 (the Act)*, specified roads in the Local Government Area of City of Parramatta Council are subject to re-classification and route variation as set out in the Schedule to this Order.

I, the Minister for Metropolitan Roads, pursuant to section 46 of the Act, by this Order, **VARY** the route of Main Road 184 by **REVOKING** the existing declaration of that road, and by **DECLARING** the road with varied routes as described in the Schedule.

By this declaration, Secondary Road SR2066 ceases to exist and becomes part of the newly declared route for Main Road 184. In addition, I declare that the former section of MR184 described in the Schedule is to be re-classified as Main Road 706.

Notification of Dedication as a Public Road

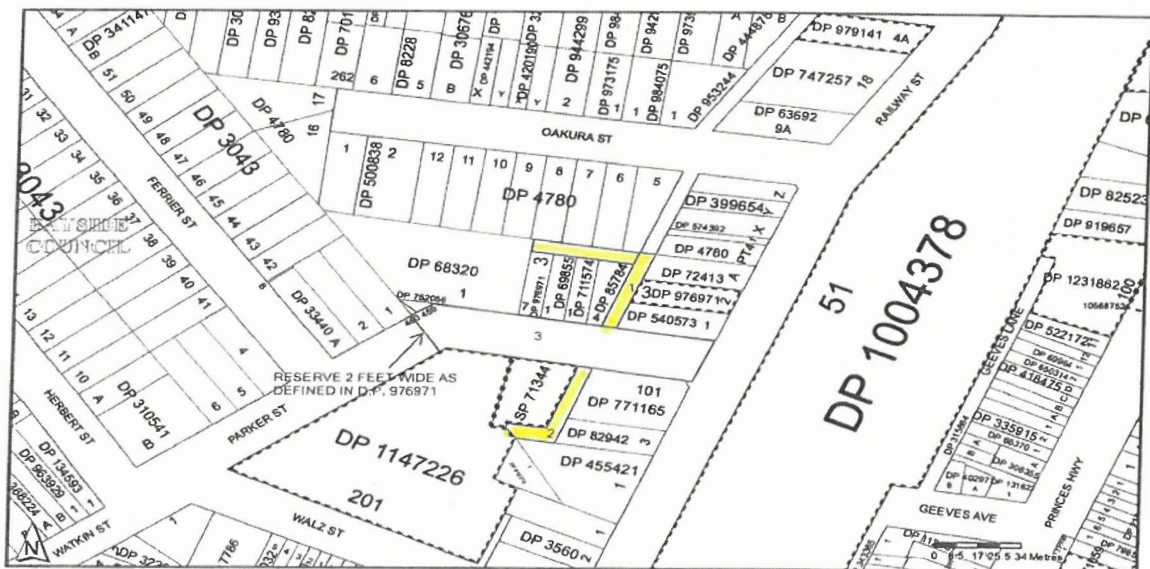

Detail

Water Ski Races will be conducted on the navigable waters of Lake Albert, Wagga Wagga as specified above. This will involve the use of powered vessels, persons being towed at speed using tow-lines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the entirety of Lake Albert, which will be monitored and maintained by event staff and control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Murray River – Entire width of the River at the following locations:

- Saturday, 25 March 2023 – Murray River between Perricoota Marina (at the 1690km marker) and upstream to the Victoria Park Boat Ramp, Echuca (at the 1712km marker), and
- Sunday, 26 March 2023 – Murray River between Torrumbarry Weir (at the 1630km river) and upstream to the Victoria Park Boat Ramp, Echuca (at the 1712km marker).

Duration

6.00am to 7.00pm on the following dates:

- Saturday 25 and Sunday 26 March 2023

Detail

Competitive water ski racing will be conducted on the navigable waters of the Murray River as specified above. The event will involve the use of high speed power vessels, persons being towed at speed using towlines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the full width of the Murray River between the locations detailed on the respective days above. The Zone will be marked at each end by the presence of patrol and control vessels. There will also be support vessels present to manage the event.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)

MINSISTERIAL ORDER MADE UNDER SECTION 19

Ministerial (Bus and Transit Lane Exemption) Order 2023

I, Natalie Ward, Minister for Metropolitan Roads, pursuant to section 19(1) of the *Road Transport Act 2013* (NSW), make the following Order.

1 Name of Order

This Order is the ***Ministerial (Bus and Transit Lane Exemption) Order 2023***.

2 Commencement

This Order has effect on and from the date of publication in the NSW Government Gazette.

3 Effect

This Order remains in force up to and including 30 June 2024 unless revoked earlier.

4 Interpretation

Words and expressions used in this Order have the same meaning as in the *Road Transport Act 2013* unless otherwise stated.

5 Application

This Order applies to a driver driving a **hire vehicle** (within the meaning of the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016*) to which is affixed a HC number-plate issued by the Authority while the vehicle is being used for the purpose of providing a passenger service under that Act.

6 Declaration

The following NSW Road Rules are declared not to apply:

- (a) Road Rule 154(1) driving in a Bus Lane other than a “Bus Only” or “Buses Only” lane.
- (b) Road Rule 156(1) driving in a Transit Lane.

7 Repeal of previous Order

The Ministerial (Bus and Transit Lane Exemption) Order 2022 published in *NSW Government Gazette No 253 (Roads and Transport)* of 10 June 2022 on pages 6 to 7 is hereby repealed on and from the commencement of this Order.

8 Publication

The Order is to be published in the NSW Government Gazette.

Explanatory note:

The object of this Order is to continue an exemption for drivers of hire vehicles with a HC number-plate issued by Transport for NSW from restrictions on the use of bus lanes and transit lanes under the Road Rules 2014 . It does not permit those drivers to drive in a bus only lane.

This Order is made under section 19 of the *Road Transport Act 2013*.

ROADS ACT 1993

Sections 46 and 47

On the recommendation of Transport for NSW pursuant to section 54 of the *Roads Act 1993* (the Act), the specified roads in the Local Government Area of Orange are subject to route classification as set out in the Schedule to this Order.

I, the Minister for Regional Transport and Roads

1. in making this Order, and pursuant to section 46(a) and (b) of the Act, **DECLARE** all unclassified roads (whether a public road or a road that joins a main road) comprising parts of the route as described in the Schedule as Highway 7, as main roads; and
2. pursuant to section 47 of the Act, **DECLARE** Highway 7 as described in the Schedule; and
3. pursuant to section 46 of the Act, by this Order, **VARY** the routes of Main Road 61, Main Road 237, Main Road 245 and Main Road 573 by **REVOKING** the existing declaration of these roads, and **DECLARING** the varied routes, and new route Main Road 705, as described in the Schedule.
