Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Wollongong City Council to advertise, designate and recruit 2 Aboriginal and Torres Strait Islander persons for the Cadet, Apprentice, Trainee and School-Based Trainee program (CATS).

This exemption will remain in force for 10 years.
