MURDER

FIVE HUNDRED THOUSAND DOLLAR (\$500,000) REWARD

On 6th February 2010 Paul Strangio was shot and killed in his home by several armed offenders whose identities remain unknown.

Notice is hereby given that a reward of up to five hundred thousand dollars (\$500,000) will be paid by the Government of New South Wales for information leading to the arrest and conviction of the person or persons responsible for the murder of Paul Strangio.

The allocation of this reward will be at the sole discretion of the Commissioner of Police.

Anti-Discrimination Act 1977

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8, 10, 25, 27, 49D, 49F and 51 of the *Anti-Discrimination Act 1977* (NSW) to Department of Regional New South Wales to:

- advertise, designate and recruit for leadership positions and create a talent pool of eligible candidates for Aboriginal and Torres Strait Islander people only in pursuance of its goal of a 6 % workforce participation rate
- develop talent pools of candidates with a specific disability for Policy and Project roles
- advertise, designate and recruit for pipeline roles and up to 45 % leadership roles for women only.

This exemption will remain in force for 3 years.
