

1 Name of Instrument

This Instrument is the *Fisheries Management (Fishing Determinations – Estuary General Fishery) Notification 2023*.

2 Interpretation

In this Instrument:

estuary general fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

estuary general species means:

- (a) pipi (*Donax deltoides*),
- (b) beachworm (Class: *Polychaeta*),
- (c) cockle (Family: *Arcidae/Veneridae*)
- (d) ghost nipper (*Trypaea australiensis*)

TAC determination has the same meaning as in section 40A of the Act.

In this Instrument:

Ocean Trap and Line Fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

OTL Plan means the Appendix to the Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006.
