REGULATION OF VESSELS – EXCLUSION ZONE

Location

Lake Macquarie, Toronto and Warners Bay – adjacent to the foreshore reserve

Duration

- 5:00pm to 7:30pm – Friday 23 June 2023
- 5:00pm to 7:30pm – Saturday 24 June 2023

Detail

A flotilla display will be conducted over the navigable waters of Lake Macquarie, Toronto on Friday 23 June 2023, and Warners Bay on Saturday 24 June 2023. The event will involve a display of brightly lit vessels transiting through the above areas.

An **EXCLUSION ZONE** is specified during the event, which will be marked with buoys and lights and monitored by control vessels stationed around the zone.


Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*).

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Port Botany – comprising all waters bounded by imaginary lines drawn at La Perouse and Kurnell (as per the attached diagram).

Duration

30 June 2023 to 30 October 2024

Detail

Ferry wharves are being constructed during the dates listed above at both the La Perouse and Kurnell sites.

An **EXCLUSION ZONE** will be in force and will be marked by yellow buoys which will be laid from the shore approximately 50 meters apart at both La Perouse and Kurnell sites.

Unauthorized vessels and persons are strictly prohibited from entering the Exclusion Zone which will be patrolled by Police, Maritime and by other official control vessels.

Penalties may apply (section 12(5) – Marine Safety Act 1998)

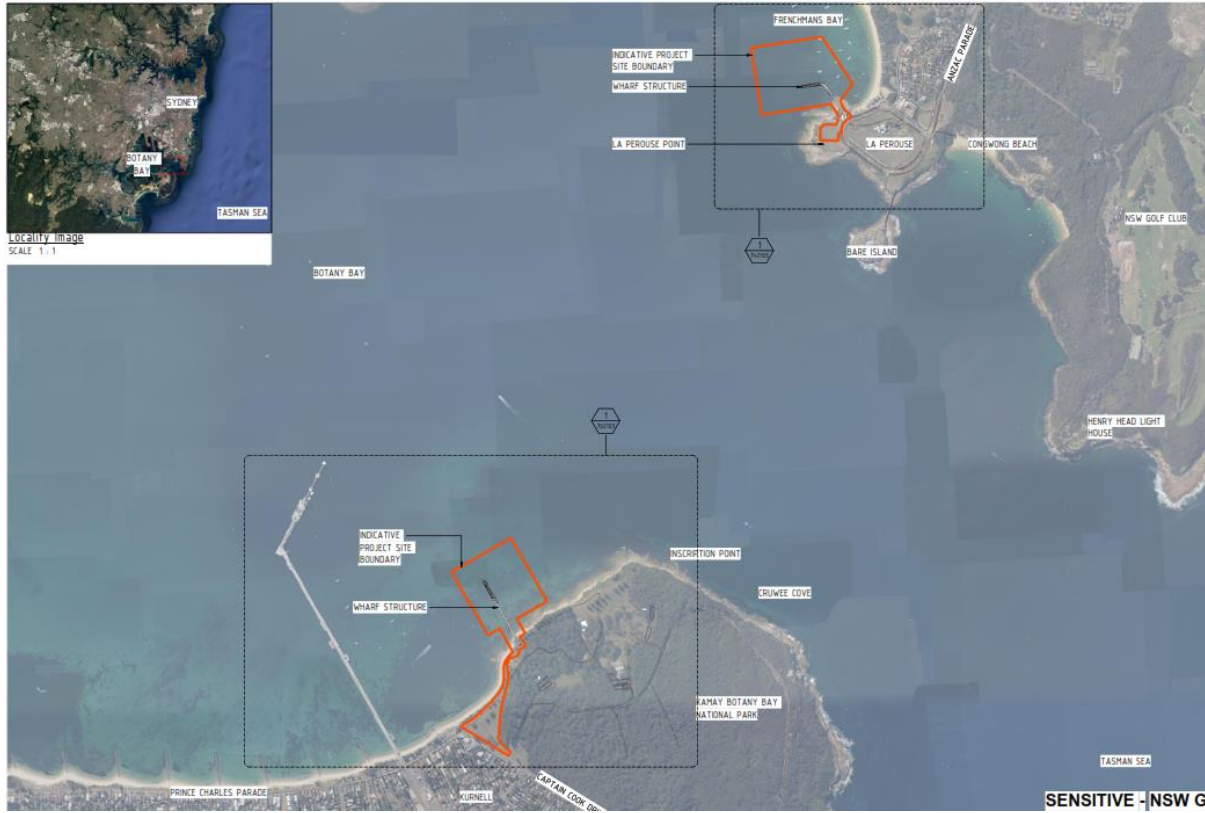
