## Appointment Instrument for Crown Land Manager

Pursuant to Part 3, Division 3.2 of the *Crown Land Management Act 2016* (the Act), the qualified person(s) named in Column 1 of the Schedule hereunder is/are appointed to be Crown land manager(s) of Crown land specified in Column 2 of the Schedule, subject to the below terms:

1. This instrument of appointment takes effect from 1 July 2023 and the reserves listed in Column 2 of the Schedule are current as at this date.
2. The person(s) named in Column 1 of the Schedule, in their capacity as Crown land manager, is required to exercise their functions in accordance with the Act, the Crown Land Management Regulation 2018, and any Crown land management rules or guidelines imposed by the Minister, or delegate under the Act.
3. Management of Crown land must adhere to the Department of Planning and Environment *Crown reserve code of conduct: For non-council Crown land managers and commons trusts* (as may be amended or replaced from time to time).
4. Provide high quality, appropriate, affordable and sustainable holiday and recreation services and facilities for the reserves listed in Column 2 of the Schedule consistent with the location, values and importance of those reserves to the people and economy of NSW.
5. Manage all natural, heritage, built assets and risks on reserves to ensure public safety and sustainability.
6. Within 24 months from the date of this appointment instrument, a Board endorsed *Management Plan* for the location is to be submitted to Crown Lands for the Minister's endorsement. The *Management Plan* is to align with NSW Crown Holiday Parks Land Manager Strategic Plan, the vision and priorities of *Crown Land 2031*, the Crown Lands State Strategic Plan, and is to specifically address how the Crown land manager will manage:
  - a. the diverse range of competing interests in the land under management
  - b. and support aboriginal interests in the land under management
  - c. the impact of and improve resilience to climate change on its reserves
  - d. the reserves and investment of proceeds using quadruple bottom line principles (that is, considering cultural, economic, environmental and social or community benefits).
7. Provide an annual update to the Minister on the progress and achievements of the Crown land manager in the delivery of the outcomes of the *Strategic Plan and the reserve specific Management Plan once it comes into effect*.

8. Provide a quarterly finance and operational report to Crown Lands against the Crown land manager's annual budget and corporate business plan
9. Comply with the directions of NSW Audit Office in the preparation of the Crown land manager's annual audit. A copy of the annual report is to be published on the Crown land manager's website.


