ORDER 2023**

I, Penny Sharpe, Minister for Energy, Minister for Climate Change, Minister for Environment and Minister for Heritage, with the concurrence of the Hon Daniel Mookhey MLC, Treasurer, make the following Order under section 34J of the *Energy and Utilities Administration Act 1987*.

Explanatory note

Section 34J of the *Energy and Utilities Administration Act 1987* provides that the Minister may, by order published in the Gazette, require any one or more licensed distributors to make an annual contribution for a specified financial year to the Climate Change Fund. The purpose of this Order is to require defined licensed distributors to make an annual contribution to the Climate Change Fund for the financial year commencing 1 July 2023.

1. Name of Order

This Order is the Energy and Utilities Administration (Energy Contributions) Order 2023.

2. Commencement

This Order commences on the date that it is published in the Gazette.

3. Interpretation

The Explanatory Note to this Order does not form part of the Order.

4. Definitions

licensed distributor means a licensed distributor listed in column 1 of Schedule 1.

5. Annual contribution

- (1) A licensed distributor is required to make an annual contribution to the Climate Change Fund for the financial year commencing 1 July 2023.
- (2) The amount of the annual contribution to be paid by a licensed distributor is as set out in column 2 of Schedule 1.

6. Time for payment

The annual contribution is to be paid by quarterly instalments (each being equal to one-fourth of the annual contribution payable) on or before the first day of August 2023, November 2023, February 2024 and May 2024.
