Farm Cove, Sydney Harbour – South of Man O' War Wharf to the northern tip of Mrs Macquaries Point

Duration

12:00am to 4:00am on the following dates:

- Monday 10 July 2023
- Tuesday 11 July 2023 (weather contingency reserve day)

Detail

A special event will take place on Sydney Harbour as specified above. The event will involve a drone show where a swarm of drones will briefly hover at low level over Sydney Harbour displaying images using lights.

An **EXCLUSION ZONE** is specified during the event which will be monitored by a safety control vessel. If the event proceeds on Monday 10 July 2023, the Exclusion Zone will not be activated on the Tuesday 11 July 2023 and will be dispensed with.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)
