ACTS OF PARLIAMENT ASSENTED TO Legislative Assembly Office, Sydney 13 July 2023

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of His Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 10 — An Act to amend the *Environmental Planning and Assessment Act 1979* to provide for housing and productivity contributions; and for other purposes. **[Environmental Planning and Assessment Amendment (Housing and Productivity Contributions) Bill]**

Act No. 11 — An Act to amend the *Crimes Act 1900* to create new offences in relation to assaults on, and other actions in relation to, retail workers; and to amend the *Criminal Procedure Act 1986* to provide for certain of the new offences to be triable summarily. **[Crimes Legislation Amendment (Assaults on Retail Workers) Bill]**

Act No. 12 — An Act to amend the *Crimes Act 1900* to create offences of having custody of a knife, or using or carrying a knife, in a public place or a school; and to make consequential amendments to other legislation. **[Criminal Legislation Amendment (Knife Crimes) Bill]**

Act No. 13 — An Act to amend the *Law Enforcement (Powers and Responsibilities) Act 2002* to enable digital evidence access orders to be sought in relation to search warrants under the *Independent Commission Against Corruption Act 1988*. **[Law Enforcement (Powers and Responsibilities) Amendment (Digital Evidence Access Orders) Bill]**
