CHARITABLE TRUSTS ACT 1993
NOTICE UNDER SECTION 15
CY PRES SCHEME RELATING TO THE
ESTATE OF THE LATE ARTHUR BUTLER

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

Under clause 4 of the Will of the late Arthur Butler, dated 8 February 1975, Mr Butler bequeathed the balance of his estate to the “Margaret Reid Hospital St Ives” to be distributed after the last of Gladwys Butler, Phillip Butler and Thea Butler died. The life interests in the Estate ended with the death of Thea Butler on 20 July 2021.

The Margaret Reid Orthopaedic Hospital for Crippled Children in St Ives (**Margaret Reid Hospital**) was a specialist orthopaedic hospital for children, a disability institution, a convalescent hospital and provided outpatient services. The gift under the Will cannot be applied to the Margaret Reid Hospital, as it ceased operating in 1981. The organisation previously known as the New South Wales Crippled Children’s Society, that operated the Hospital, has changed its name several times and is currently known as the Northcott Society.

The bequest to Margaret Reid Hospital is considered to be intended to be a gift applied for the charitable purposes of the hospital. As such, the trustees hold the residue of the Estate on trust for the charitable purposes of the Margaret Reid Hospital, which fall within the charitable purposes of being the relief of the impotent and for purposes beneficial to the community.

The Margaret Reid Hospital previously operated an Orthopaedic Appliance Service providing services such as specialist orthotics products, orthopaedic shoes, special seating and modified wheelchairs to people with disabilities. As the gift was made out to the Margaret Reid Hospital generally, it appears to have been intended to support the continuation of the services provided to its patients. As the Margaret Reid Hospital no longer exists, the original terms of the trust have become impossible to fulfil.

Northcott Society has been identified as providing an Orthotics and Custom Footwear service which provides children with customised orthotics, orthoses and medical grade footwear. This appears to be very closely aligned with the Orthopaedic Appliance Service previously operated by the Margaret Reid Hospital.

The trustees of the estate have no objection to a cy pres scheme applying the funds for the benefit of the Northcott Orthotics and Custom Footwear service.

In these circumstances, the Solicitor General, as the Attorney General’s delegate, has approved the establishment of a cy pres scheme so that the bequest to Margaret Reid

Hospital is to be held on trust by the Northcott Society to be used for children accessing its Orthotics and Custom Footwear service.

EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8, 25 and 51 of the *Anti-Discrimination Act 1977* (NSW) to HVTC PTY LTD to designate and recruit:

- 70 non-traditional trade traineeship and apprenticeship positions for women only
- 70 traineeship and apprenticeship positions for Aboriginal and Torres Strait Islander persons only.

This exemption will remain in force for 4 years.

CHARITABLE TRUSTS ACT 1993
NOTICE UNDER SECTION 15
CY PRES SCHEME RELATING TO THE
JOHN AND LILLIAN FRANCES LAYCOCK PRIZE

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

The John and Lillian Frances Laycock Memorial Prize (**the Prize**) was established by an *inter vivos* gift to the University of Sydney (**the University**) by Mr John Field Laycock (**Mr Laycock**) in 2008 for proficiency in anatomy or physiology by students enrolled in their final years of the Bachelor of Medicine and Bachelor of Surgery (**MBBS**). As at 29 June 2023, the Scholarship was valued at \$33,337.

In 2014, the University replaced the undergraduate MBBS with a postgraduate degree of Doctor of Medicine. The last cohort of MBBS was in 2013. As the undergraduate MBBS is no longer offered at the University, the original terms of the trust have become impossible to fulfil.

The University holds the gift from Mr Laycock on an express trust for the purpose of awarding a prize. Trusts for the establishment of an award of prizes and scholarships for students at educational institutions or for study in a recognised field, such as medicine, are charitable as they fall within the charitable head of advancement of education.

As the University now offers medicine at a postgraduate level, with anatomy and physiology taught across different subjects at different year levels, a cy pres scheme is required to remove the requirement that a student must be enrolled in their final years of the MBBS. The proposed scheme would instead require the recipient to be enrolled in a medical degree at the University. The condition that the Prize would be awarded to the student who is most proficient in anatomy or physiology would continue.

As it appears Mr Laycock intended that the gift be for the benefit of medical students at the University, rather than for students enrolled in an undergraduate degree in medicine at a different University, the proposed new trust purpose is sufficiently close to the original purpose of the trust.

In these circumstances, the Solicitor General, as the Attorney General's delegate, has approved the establishment of a cy pres scheme to alter the original purposes of the charitable trust so as to enable the Prize to be awarded to students enrolled in a medical degree.
