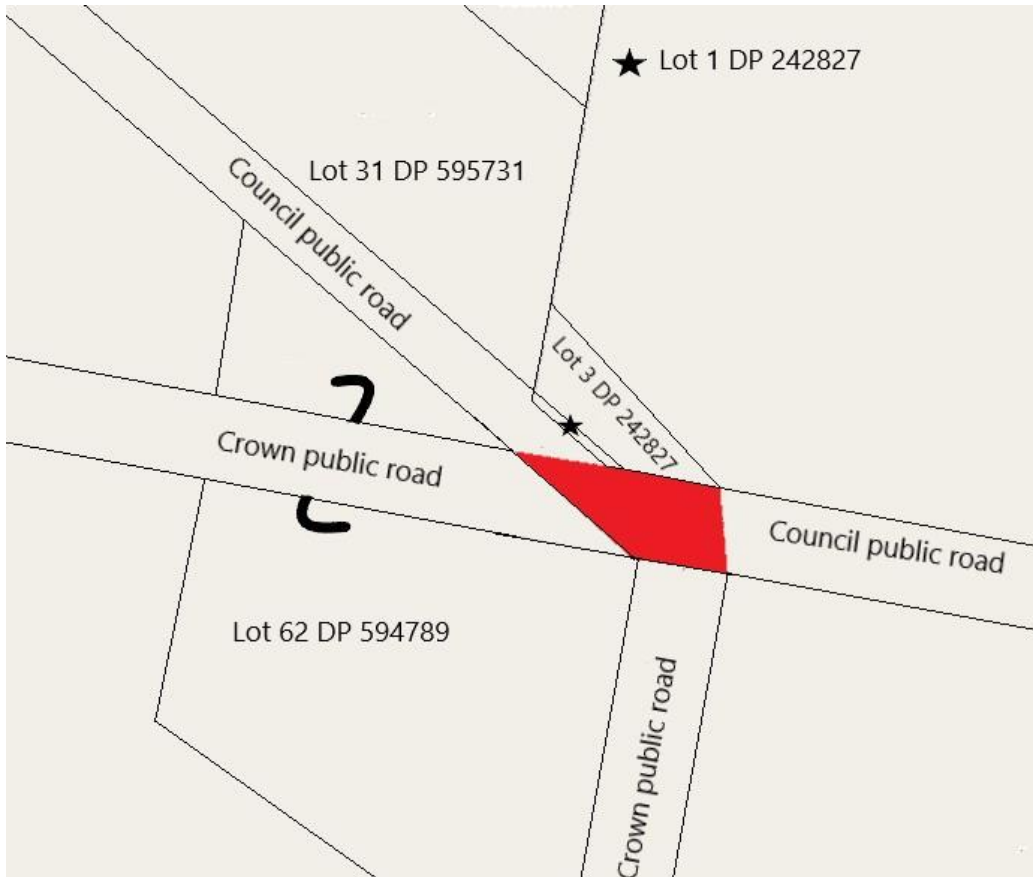
**ERRATUM**

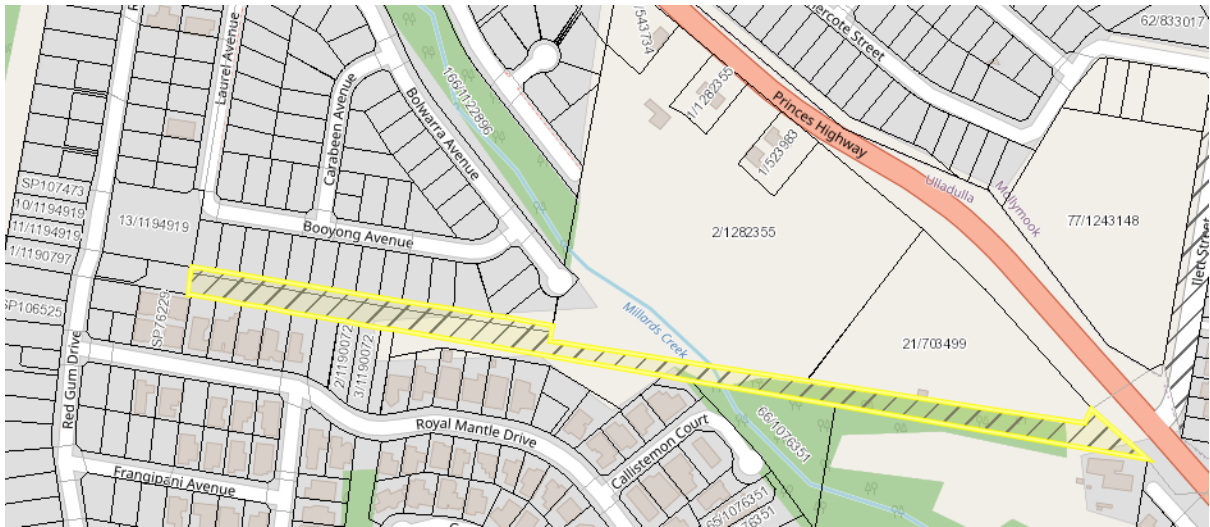
