EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Shellharbour City Council.

This exemption is to designate, advertise and recruit for one Team Leader Bush Regeneration position for an Aboriginal or Torres Strait Islander person only.

This exemption will remain in force for 10 years.
