# **Exemption from Mining Act 1992** SECTION 6 (OPAL PUDDLING) ORDER 2024

1. Exemption

The class of persons specified in Column 1 of Schedule 1 is exempt from the operation of section 6 of the *Mining Act 1992* (Act) with respect to the carrying out of the class of designated ancillary mining activities specified in Column 2 of Schedule 1.

#### 2. Duration

This Order takes effect on the day that it is published in the *New South Wales Government Gazette* and will cease to have effect 1 year after the day this Order is published in the Gazette.

#### 3. Interpretation

- (1) Unless otherwise stated, words and expressions that are defined in the Act or the Regulation have the same meaning in this Order.
- (2) In this Order—

small portable mixer means equipment which—

- (a) consists of a drum with a capacity of less than 200 litres, and
- (b) is supplied with water from a single hose with a width of less than 19 millimetres, and
- (c) may be attached to, or separated from, drilling apparatus.

  - (a) the holder fulfils the requirements of paragraphs (a)-(c) of paragraph 1 above, and
  - (b) the mining lease or mineral claim authorises the carrying out of opal puddling, and
  - (c) the holder of the licence has the other person's prior written agreement to carry out opal puddling on that land.

Coal Operational Allocation Framework




# Market Interest Test - Coal Operational Allocation

Market Interest Test submission closing: Sunday 24 November 2024 at 11:59pm (AEST)

Bengalla Mining Company Pty Limited (ACN 053 909 470) has applied to NSW Resources for a Group 9 (coal) exploration licence for operational allocation purposes in accordance with section 13C of the *Mining Act 1992*.

Exploration Licence Application No. 6831 (Act 1992) (ELA 6831) is located about 11 kilometres west of Muswellbrook, over an area of approximately 739 hectares. ELA 6831 embraces the surface and soil below thereof to a depth of 900 metres below Australian Height Datum (AHD).

NSW Resources is required to assess any market interest for the application by Bengalla Mining Company Pty Limited – ELA 6831 and is seeking submissions from parties interested in exploring and potentially developing coal resources within the application area.



The application area where submissions are being sought can be seen in the diagram.

Any valid submissions may trigger a competitive process for the release of the area. Submissions should only be made where a party has a genuine interest in making an application for an exploration licence and where interested parties are willing to participate in a competitive process if it is triggered.

This notification is pursuant to section 13C(3A)(b) of the *Mining Act 1992* and the *Guidelines for coal exploration licence applications for operational allocation purposes* and does not constitute an invitation for a coal exploration licence or mining lease nor a release of the area under the Strategic Release Framework.
