### 1 Name of Order

### 2 Commencement

### 3 Definitions

In this Order:

*local government area* means an area within the meaning of the *Local Government Act 1993*.

*parish* means a part of a county the administrative boundaries of which are described in the digital cadastral database maintained by Spatial Services in the Department of Customer Service.

### 4 Declaration of reconstruction area – the Act, s 40

The part of the State comprising the following areas is declared to be a reconstruction area -

- (a) the following local government areas -

  - (iii) Lachlan Shire,
  - (iv) Cabonne Shire,

- (b) the parishes of Guagong, Booberoi, Euabalong, Eribendery, and Whoey in Cobar Shire local government area.
