## Anti-Discrimination Act 1977

## EXEMPTION ORDER

Under the provisions of section 126 of the Anti-Discrimination Act 1977 (NSW), an exemption is given from sections 8 and 51 of the Anti Discrimination Act 1977 (NSW) to The University of Notre Dame.

This exemption is to designate, advertise and recruit positions for Aboriginal or Torres Strait Islander persons only, in pursuance of its goal of a 3% workforce participation rate.

This exemption will remain in force for 5 years.
