REGULATION OF VESSELS – EXCLUSION ZONE

Location

Corcoran Park Clarence River, Western side of Elizabeth Island.

Duration

- 8:00am to 6:00pm - Sunday 10 November 2024.

Detail

Power boat races will be conducted on the navigable waters as specified above, involving the use of high speed power vessels presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified at the above location while the event is in progress. The course will be marked by buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the time above.

Unauthorized vessels and persons are strictly prohibited from entering the Exclusion Zone during the above times.

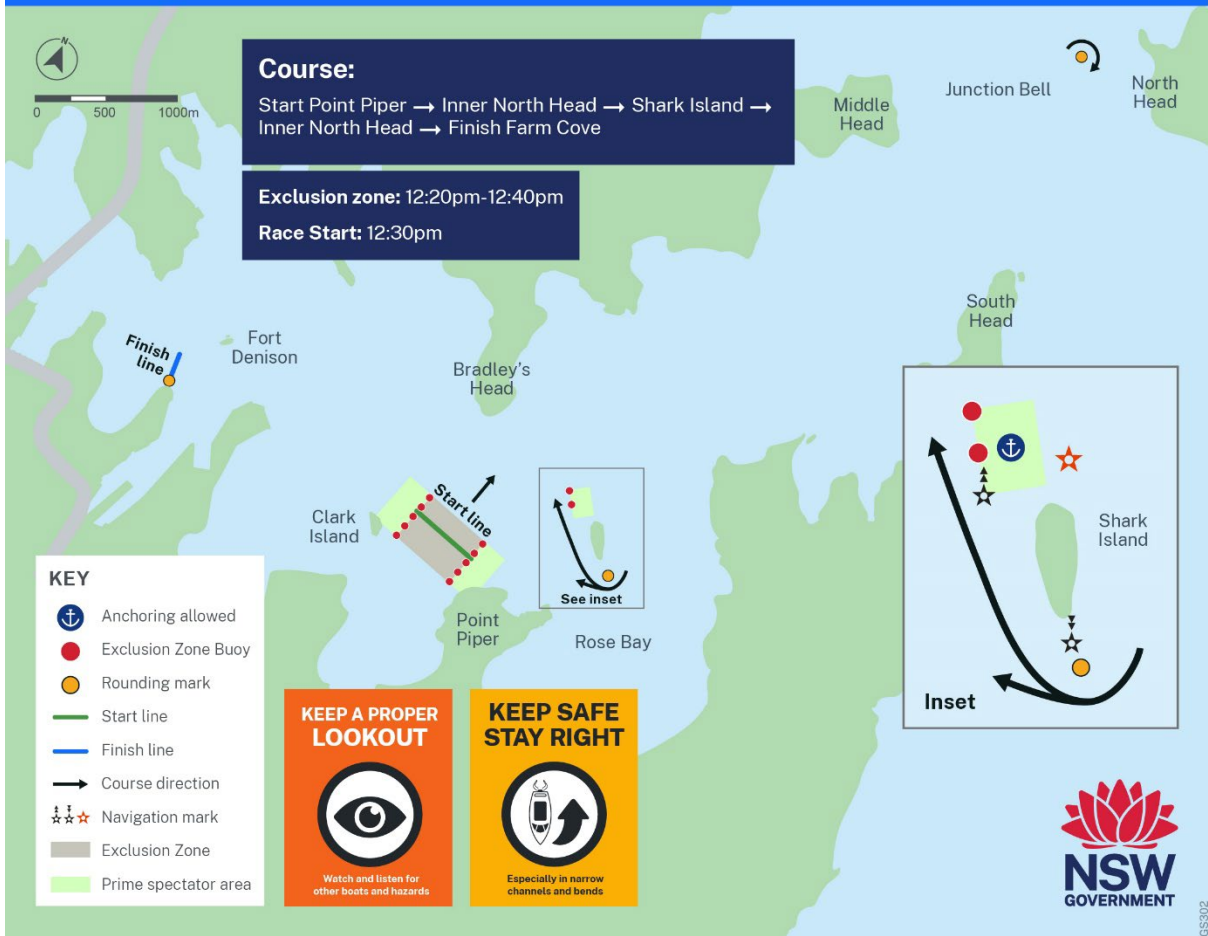
