# GAZETTE NOTICE

## SUBORDINATE LEGISLATION ACT 1989 Draft Prevention of Cruelty to Animals Regulation 2025

Notice is given in accordance with section 5 of the *Subordinate Legislation Act 1989* of the intention to make a regulation under the *Prevention of Cruelty to Animals Act 1979*.

The NSW Government is seeking your feedback on draft changes to the Prevention of Cruelty to Animals Regulation 2012 (the POCTA Regulation). These changes are included in the draft Prevention of Cruelty to Animals Regulation 2025 (the draft Regulation) that will replace the POCTA Regulation on 1 February 2025.

The *Prevention of Cruelty to Animals Act 1979* (the Act) is the primary legislation that sets the foundation for strategic and coordinated management of animal welfare in NSW. The Act is supported by the POCTA Regulation.

Key amendments in the draft Prevention of Cruelty to Animals Regulation 2025 include:

- Revising the circumstances with which certain procedures can be carried out on animals such as declawing of cats, debarking of dogs and tail docking of cattle under 6 months of age.
- Prohibiting the use of glue traps for the purpose of catching animals but will still be allowed for use on insects.
- Improving the enforcement options by allowing the use of penalty notices for additional offences and increasing the existing penalty notice amounts for a range of offences.
- Implementing some requirements from the Poultry Standards and Guidelines for laying fowl to build upon existing layer fowl regulations.

## SUBORDINATE LEGISLATION ACT 1989

### Food Regulation 2025

Notice is given in line with section 5 of the *Subordinate Legislation Act 1989* of the intention to make a Regulation under the *Food Act 2003*.

The draft Food Regulation 2025 is proposed to replace the Food Regulation 2015 which will automatically be repealed on 1 September 2025.

The *Food Act 2003* establishes coordinated management of the handling and sale of food to ensure it is safe and suitable for human consumption, to prevent misleading conduct in connection with the sale of food, and apply the Australia New Zealand Food Standards Code in NSW.

The Regulation requires best practice food safety arrangements across high-risk food sectors and promotes the production and sale of safe, reliable, and high-quality food in NSW.

Amendments to the Regulation are proposed to:

- introduce a licensing scheme for growers and processors of berries, leafy vegetables and melons to implement new national standards in the Code
- establish a plant products industry consultative committee
- broaden application of the Australian Standards for abattoirs and meat processing plants
- make food safety measures to manage *Salmonella* Enteritidis permanent requirements for licensed egg producers
- change requirements for businesses regarding notification of analysis results to the Food Authority to enable a faster response to food safety issues
- insert a new requirement for laboratories to notify certain analysis results to the Food Authority to enable earlier detection of food safety issues
- introduce a new fee for businesses to recover enforcement agency costs associated with permitting a business to resume operation after receiving a prohibition order due to a serious food safety issue
- ensure students receive all training and assessment, and their Food Safety Supervisor certificate is issued promptly after completing training and assessment
- increase fees and penalty notice amounts by CPI and align fees across food safety schemes
- clarify, simplify and update references.

Some other minor amendments have been made in the draft Food Regulation 2025 to adhere to current plain English drafting guidelines and to make the Regulation clearer. These changes do not alter the function or outcome of the Regulation.
