Location

Edward River – near the Deniliquin Boat Club on Riverview Drive (Deniliquin) as follows:

- Upstream 400 metres of the Deniliquin Boat Club and adjacent to the Big 4 Deniliquin Holiday Park, to
- Downstream 400 metres of the Deniliquin Boat Club and adjacent to the Warbreccan Homestead.

Duration

On the following dates and times:

- 7:00am to 7:00pm Saturday 7 December 2024.
- 7:00am to 7:00pm Sunday 8 December 2024.

Detail

A wakeboarding competition will be conducted on the navigable waters of the Edward River as specified above. The event will involve the use of powered vessels, persons being towed at speed using tow-lines and persons in the water, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be indicated by buoys, monitored by control vessels and patrolled by NSW Maritime vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Transit lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'.

Special Restrictions

Pursuant to section 12(3) of the *Marine Safety Act 1998*, all vessels using the transit lane must do so at a speed not exceeding 4 knots and must produce minimal wash.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Transit lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the Exclusion Zone via a 'transit lane'.

SPECIAL RESTRICTIONS apply to vessels using the transit lane. Pursuant to section 12(3) of the Act, vessels navigating through the transit lane must do so at a speed not exceeding 6 knots and must produce no wash.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).




An **EXCLUSION ZONE** is specified during the event (as per the below diagram) which will be monitored and indicated by the presence of control vessels on the boundary.

PROHIBITION ON POWER DRIVEN VESSELS

Location

Brisbane Water, Ettalong

Duration

Commencing Friday 22 November 2024 until this Notice is revoked or replaced.

Detail

Due to the potential to affect the safety of the public and the amenity of users of the waterway at the location, by this Notice, all power driven vessels (including personal watercraft) are prohibited in the shaded area depicted on the map below.

The Area extends from the foreshore in the vicinity of 66 The Esplanade, Ettalong approximately 300 meters northeast to a point on the shoreline at the corner of The Esplanade, Ettalong and Picnic Parade Ettalong.

The area will also be marked on the shoreline with signage showing "Paddle Craft Only" in directions indicated on the signs.


This Notice does not affect the use of the Area by swimmers.

Power driven vessels are strictly prohibited from entering the Area (regardless of whether they are operating or not).
