# POISONS AND THERAPEUTIC GOODS REGULATION 2008

#### ORDER

### Withdrawal of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation* 2008 an Order has been made on **Dr Assadour Avedis Ekmejian (MED0001160747)** of Marsfield NSW 2122, prohibiting him until further notice, as a medical practitioner, from supplying or having possession of drugs of addiction as authorised by clause 101 of the Regulation and issuing a prescription for a drug of addiction as authorised by clause 77 of the Regulation.

This Order is to take effect on and from 6 December 2024.

IT is hereby notified, for general information, that Her Excellency the Governor has, in the name and on behalf of His Majesty, this day assented to the undermentioned Acts passed by the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, viz.:

Act No. 95, 2024 – An Act to amend the Transport Administration Act 1988 to establish NSW Motorways and make provision for its functions, management and status; and for related purposes. [Transport Administration Amendment (NSW Motorways) Bill 2024]

Act No. 96, 2024 – An Act to amend the Biodiversity Conservation Act 2016 to reform the biodiversity offsets scheme; and to make consequential amendments to the State Environmental Planning Policy (Biodiversity and Conservation) 2021. [Biodiversity Conservation Amendment (Biodiversity Offsets Scheme) Bill 2024]

#### Criminal Assets Recovery Act 1990 (section 21C)

# **ASSETS FORFEITURE NOTICE**

In accordance with section 21C of the *Criminal Assets Recovery Act* 1990 (**the Act**), the New South Wales Crime Commission (**the Commission**) hereby issues a notice of intention to forfeit (**assets forfeiture notice**) the following property,

Cash in the amount of \$300,000 in Australian currency (**the property**) and any interest earned thereon, found and subsequently seized by officers of the New South Wales Police Force ('NSWPF') on 16 June 2024 following a search of a white Mercedes van, with a State of Victoria registration BCK011, on the Hume Highway, South Gundagai, to the Crown.

This assets forfeiture notice is issued on the following grounds:

- 1. The property is held by the NSWPF after it was a seized as a result of a search on 16 June 2024, of a white Mercedes van, with a State of Victoria registration BCK011, on the Hume Highway, South Gundagai. On that day, the person in possession of the property, being the driver of the vehicle, denied ownership or knowledge of the property. The property is held by NSW Police pursuant to the Law Enforcement (Powers and Responsibilities) Act 2002.
- 2. The Commission is reasonably satisfied the property is an interest in property:
  - a. of a person suspected of engaging in serious crime related activity; and/or
  - b. suspected of being serious crime derived property because of serious crime related activity; and/or
  - c. suspected of being an available interest relating to serious crime use property, within the meaning of the Act.

Pursuant to section 21A of the Act, a dispute claim in relation to this assets forfeiture notice may be made by **4 February 2025** and pursuant to section 21G of the Act, **MUST**:

- 1. be made in writing to the Commission by post to 453-463 Kent Street, Sydney, NSW or by e-mail to confiscations@crimecommission.nsw.gov.au; and
- 2. include the following information:
  - (a) the name, date of birth and address of the person making the claim (**the claimant**),
  - (b) the basis of the claim, including the following and evidence, if any, supporting the following
    - (i) a description of the claimant's interest in the property,
    - (ii) how the interest in the property was acquired,
    - (iii) why the interest in the property is not illegally acquired property,
  - (c) a statutory declaration supporting the information in the claim.

Unless a dispute claim is made to the Commission, this assets forfeiture notice takes effect immediately after **4 February 2025**.

Act No. 86 — An Act to amend the *Royal Botanic Gardens and Domain Trust Act 1980* to provide for certain matters in relation to Trust lands. **[Royal Botanic Gardens and Domain Trust Amendment Bill]** 

Act No. 87 — An Act to amend the *Public Health (Tobacco) Act 2008* and the *Public Health (Tobacco) Regulation 2022* to establish a licensing scheme to regulate the sale of tobacco products and non-tobacco smoking products; to provide for clearer offences relating to the display of prices and brands and to increase penalties for particular offences; and for related purposes. [Public Health (Tobacco) Amendment Bill (No 2)]

Act No. 88 — An Act to amend the *State Insurance and Care Governance Act 2015* to provide for improved governance arrangements and transparency in relation to Insurance and Care NSW. [State Insurance and Care Governance Amendment (Governance Arrangements) Bill]

Act No. 89 — An Act to amend the *Witness Protection Act 1995* to provide additional protection for and assistance to participants and former participants in the witness protection program and to provide for the disclosure and secure management of certain information relating to the program; to make consequential amendments to the *Surveillance Devices Act 2007*; and for other purposes. [Witness Protection Amendment Bill]

Act No. 90 — An Act to make miscellaneous amendments to certain revenue legislation; and for other purposes. [Revenue Legislation Further Amendment Bill]

Act No. 91 — An Act to amend the *Environmental Planning and Assessment Act 1979* in response to a recent court decision impacting State significant development consents. **[Environmental Planning and Assessment Amendment (State Significant Development) Bill]** 

Act No. 92 — An Act to amend the *Victims Rights and Support Act 2013* in relation to the eligibility of family victims of road crimes for approved counselling services; and for related purposes. [Victims Rights and Support Amendment (Victims Support Counselling) Bill]

Act No. 93 — An Act to amend the *Crimes Act 1900* to provide for a monetary penalty for obstructing a railway. [Crimes Amendment (Obstructing a Railway) Bill]



Act No. 94 — An Act to amend the *Poisons and Therapeutic Goods Act 1966*, the *Medicines, Poisons and Therapeutic Goods Act 2022*, the *Criminal Procedure Act 1986*, the *Public Health (Tobacco) Act 2008* and the *Smoke-free Environment Act 2000* for particular purposes. [Public Health (Tobacco) Amendment Bill]
