REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Kiama Harbour and the Tasman Sea – adjacent to the Kiama Breakwall on the northern side of Kiama Harbour.

Duration

• 7:00pm to 11:00pm – Tuesday 31 December 2024.

Detail

A fireworks display will be conducted over the navigable waters of Kiama Harbour and the adjacent waters of the Tasman Sea as specified above. The waterway directly around the firing location may be dangerous and hazardous to waterway users.

An **EXCLUSION ZONE** extending for a radius of 200 metres around the display is specified during the event, which will be monitored and indicated by event personnel.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the time above.

Special Restrictions

Pursuant to section 12(3) of the *Marine Safety Act 1998*, for the duration of the event, special restrictions are imposed on all lawfully moored vessels within the Exclusion Zone whilst it is in force as follows:

 Vessels moored within the area must remain at their position and MUST NOT be operated during the event.
